I do hereby lodged a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Uttam Bera, S/O- Lt. Jogeshwar Bera of Vill: Jamrah Shyampur, P.O-Bodhra, P.S-Mandarmoni Costal, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 22.12.2016 at about 03:40 PM, I Sri Bhutnath Mudi, SAE & SM, Digha CCC along with Sri Manas Maity, A.E.[U], (S&LP), Contai Division Office, and Sri Sushanta Das, TSH Digha CCC and others had been to the Vili: Jamrah Shyampur, P.S-Mandarmoni Costal for routine inspection purpose. At first we went to the Domestic premises Sri Uttam Bera, S/O- Lt. Jogeshwar Bera of Vill: Jamrah Shyampur, P.O-Bodhra, P.S-Mandarmoni Costal, Dist-Purba Medinipur and during inspection it was found that Sri Uttam Bera, S/O- Lt. Jogeshwar Bera of Vill: Jamrah Shyampur, P.S-Mandarmoni Costal, Dist-Purba Medinipur consuming electricity unauthorisedly by the way of tampering the service cable for bypassing the energy meter with the help of separate bypass wire for his wrongfull gain in respect of Consumer Id No: 223186590, Meter No: T1666314, for less recording of energy through the installed energy meter, causing loss of revenue to WBSEDCL in the tune of load 0.88 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of tampered 2 core black colour round shape PVC coated aluminum conductor of length 2 (two) meter (approx) alongwith bypass arrangement were seized under memo of seizure list in presence of witnesses Arati Bera, W/O- Lt. Hriday Bera (i.e. younger sister of accused) and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of Arati Bera, W/O- Lt. Hriday Bera and signature of witnesses and representative of the consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 03:55 PM.

Thus Sri Uttam Bera, S/O- Lt. Jogeshwar Bera of Vill; Jamrah Shyampur, P.O-Bodhra, P.S-Mandarmoni Costal, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.
