I, SI Pranab Samanta of Moyna PS do here by lodged complaint against Nirban Jana (55 yrs) s/o Lt Bankim Chandra Jana of Purba Dobandi, P.S. Moyna, Dist. Purba Medinipur, to the effect that on 02.04.17 at 18:45 hrs. SI Prasun Paria of Moyna P.S. received secret information that illegal sale of I.D. liquor is going on at Purba Dobandi, P.S Moyna. This has a reference to Moyna P.S. GDE No 56 dtd. 02.04.17

. I have been directed to work out the information and accordingly myself along with C/ 710 Dipak Ranjan Roy, C/1247 Badal Ch. Pachal both of Moyna P.S who were already detailed for evening mobile duty vide Moyna P.S C.C No961/17 dtd.02.04.17 left for to work out the information.

On 02.04.17 at 19:25 hrs. myself accompanied with force reached at Purba Dobandi and identified the liquor shop cum house and held raid at the liquor shop of Nirban Jana. Seeing police some persons who were seating and consuming 1.D liquor started to flee away but shop owner was apprehended, It revealed that the accused Nirban Jana is selling unauthorized liquor to consumer violating the law of the land relating to such stock and sale governed in the Bengal Excise Act.

On 02.04.17 in between 19:35 hrs, to 20:05 hrs. searched the shop and found approx 10 (Ten) liters I.D. liquor (cholai) in a plastic jerkin valued Rupees 70/- (Seventy) per liter approx.(Total valued Rs 70 X 10 =Rs.700/- approx), which I seized duly signed by the seller and Police witnesses, as no local public person turned up on request. Sample was taken on the spot duly sealed and labeled by me.

In spite of my several request the said shop keeper Nirban Jana could not be able to produce the license or any valid document for selling those liquor and confessed that he actually stocked ID liquor at his house cum shop situated under Mouza Purba Dobandi and selling illegally.

On enquiry it came to learnt that Nirban Jana continuing this illegal business since long causing loss of Govt. revenue. Hence was taken into custody after issuing memo of arrest duly signed by him as he violated the provision of sec 18 (1) of Bengal Excise Act and he committed an offence u/s 46 A (C) of Bengal Excise Act, 1909.

Under the above circumstances I request you to start a specific case against Nirban Jana (55 yrs) s/o Lt. Bankim Chandra Jana of Purba Dobandi, P.S. Moyna, Dist. Purba Medinipur (owner of the I.D liquor shop cum seller) and arrange for its investigation.
