Dear Sir,

I do hereby lodged complaint, empowered by the electricity act 2003 to the effect that Sri Debabrata Hazra, S/O-Dipak Hazra, vill,- Harduachak, P.S. -Moyna, Dist - Purba Medinipur, has committed theft of electricity u/s 135 of the Electricity Act 2003 read with amendment Act 2007 as stated hereunder.

On 04.04.2017 at 12:15 p.m, I,Sri Dibyendu Sekhar Bhunia,DE(S&LP),Regional Office ,Purba Medinipur along with 1) Sri Abhijit Das,AE & SM,Moyna CCC (2) Sri Partha Kolay, SAE(E),Moyna CCC (3) Sri Gouri Shankar Mahapatra, Hr.Gr.Sr.LM, Moyna CCC and other officials had been into the village Harduachak for inspection purpose. At first we visited the domestic premises of consumer named Sri Debabrata Hazra vide reference ID no - 222092974 and meter no - ML524207. During inspection it was found that Sri Debabrata Hazra was consuming power dishonestly by way direct hooking from nearby LT overhead line bypassing the meter for less recording of energy meter for wrongful gain, thereby causing loss of WBSEDCL's revenue. On physical verification the assessed load was detected 1 KVA

As theft of electricity was detected during inspection at first before seizure the service connection of the consumer was disconnected with removal of the unauthorized hooking wire and thereafter some portion of unauthorized wire single core PVC wire white color 5 meters approx. and one yellow card SL No: 0412204 in the name of Debabrata Hazra were seized under a memo of seizure list in presence of the witnesses and duly signed by the witnesses on it. The said seized wire was utilized for theft in respect of power. I also prepared an inspection report at site duly signed by witnesses on it. I also approached to the accused/representative to sign on the seizer and inspection report but they refused to sign on it.


The above wire was duly packed, labeled at the inspection site and signature of the witnesses obtained on the label. The inspection team left the premises at 12:40 pm.

Thus the accused person that Sri Debabrata Hazra S/O-Dipak Hazra, Vill,- Harduachak, P.S. -Moyna, Dist - Purba Medinipur, has committed an offence u/s 135(1)(b) of the Electricity Act 2003 read with amendment Act 2007 under the per view of theft in respect of electricity of WBSEDCL.

You are requested to take cognizance of this complaint and treat it as FIR.
