Sir,

In producing herewith arrested accuse namely Sukdev Das (30 yrs.) s/o Lt Bhim Charan Das of Gobradan, P.S. Moyna, Dist Purba Medinipur, (owner of illegal LD liquor shop cum seller). I, SI Pranab Samanta of Moyna PS do here by lodged complaint against Sukdev Das (30 yrs) s/o Lt Bhim Charan Dasof Gobradan, P.S. Moyna, Dist. Purba Medinipur, to the effect that on 06.04.17 at 14:45 hrs. ASI Ajoy Mridha of Moyna P.S. received secret information that illegal sale of LD. liquor is going on at Gobradan, P.S Moyna. This has a reference to Moyna P.S. GDE No 229 dtd. 06.04.17

. I have been directed to work out the information and accordingly myself along with C/ 555 Amit Bhownik, C/1440 Ujjal Kanti Bodak both of Moyna P.S who were already detailed for mobile duty vide Moyna P.S C.C No 998/17 dtd.06.04.17 left for to work out the information.

On 06.04.17 at 15:15 hrs. myself accompanied with force reached at Gobradan and identified the liquor shop cum house and held raid at the liquor shop of Sukdev Das. Seeing police some persons who were seating and consuming LD liquor started to flee away but shop owner was apprehended, It revealed that the accused Sukdev Das is selling unauthorized liquor to consumer violating the law of the land relating to such stock and sale governed in the Bengal Excise Act.

On 06.04.17 in between 15:25 hrs, to 15:55 hrs. searched the shop and found approx 10 (Ten) liters 1.D. liquor (cholai) in a plastic jerkin valued Rupees 70/- (Seventy) per liter approx.(Total valued Rs 70 X 10 =Rs.700/- approx), which I seized duly signed by the seller and Police witnesses, and 1) Narayan Mal s/o Lt Nagendranath Mal of Bakcha PS Moyna, Dist. Purba Medinipur. Sample was taken on the spot duly sealed and labeled by me.

In spite of my several request the said shop keeper Sukdev Das could not be able to produce the license or any valid document for selling those liquor and confessed that he actually stocked ID liquor at his house cum shop situated under Mouza Gobradan and selling illegally.

On enquiry it came to learnt that Sukdev Das continuing this illegal business since long causing loss of Govt. revenue. Hence was taken into custody after issuing memo of arrest duly signed by him as he violated the provision of sec 18 (1) of Bengal Excise Act and he committed an offence u/s 46 A (C) of Bengal Excise Act, 1909.

Under the above circumstances I request you to start a specific case against Sukdev Das (30 yrs) s/o Lt. Bhim Charan Das of Gobradan, P.S. Moyna, Dist. Purba Medinipur (owner of the LD liquor shop cum seller) and arrange for its investigation.
