I, SI Prasun Paria of Moyna PS in producing here with the accused persons (1) Uttam Kumar Maity (39 yrs) s/o Lt Kshudiram Maity; (2) Rikta Bhowmik (Maity) (34 yrs) w/o Uttam Kumar Maity both of Janakichak PS Moyna Dist Purba Medinipur and here by lodge a written complaint to the effect that today (06.04.2017) myself along with SI Joydev Mondal, C/ 627 Sailendra Nath Sarkar, C/758 Tapan Samanta and L/C 1813 Indrani Sheet all of Moyna PS were engaged for mobile duty from 14:15 hrs, vide Moyna PS CC No. 1002/17, Dated 06.04.2017 and GDE No 226, Dated 06.04.2017 with government vehicle vide registration no WB 30 B/1007. Around 15:45 hrs we reached at Natunpukur Mandir Morh on Moyna - Pingla pitch road for performing vehicle checking duty. At about 16:15 hrs we detected that one Motor Cycle rider with one pillion rider by a motor cycle bearing Regd No WB 30K/1501 was moving towards Balaiponda from Hoglabari side on Moyna - Pingla pitch road without headgear. Then maintaining all formalities the said motor cycle has been stopped and on being asked the said motorcycle rider - Uttam Kumar Maity s/o Lt Kshudiram Maity of Janakichak PS Moyna Dist Purba Medinipur, produced documents and after scrutinize accordingly I issued compound slip against the said - Uttam Kumar Maity s/o Lt Kshudiram Maity of Janakichak PS Moyna Dist Purba Medinipur, u/s 177 MV Act in respect of vehicle bearing Regd No WB 30K/1501 and they left for their destination towards Balaponda through Moyna - Pingla pitch road.

Thereafter we were performing our duty as usual. Around 17:00 hrs the said rider - Uttam Kumar Maity s/o Lt Kshudiram Maity of Janakichak PS Moyna Dist Purba Medinipur with one female pillion rider came and suddenly they restrained us used filthy and abusive languages, threatened with dire consequence, made obstruction for vehicle checking there, suddenly the female pillion rider slapped me with her sandal at my cheek, hand and body repeatedly, assaulted by fist and blows and said Uttam Kumar Maity s/o Lt Kshudiram Maity of Janakichak PS Moyna Dist Purba Medinipur hold my collar and they jointly bring down a brutal assault upon me and pushed me down with lathi and by blowing fist and kick repeatedly at several parts of my body and lower abdomen and threatened me and my colleagues with dire consequence.

My colleagues rescued me and apprehended them and on interrogation the male person disclosed his identity as - Uttam Kumar Maity (39 yrs) s/o Lt Kshudiram Maity and the female pillion rider disclosed her identity as Rikta Bhowmik Maity (34 yrs) w/o Uttam Kumar Maity both of Janakichak PS Moyna Dist Purba Medinipur .They committed the offence of obstructing public servant, discharge of public function, threatened public servant with dire consequence and assaulted brutally, so I arrested them maintaining all norms and formalities and observing all rules properly and seized the M/C bearing registration no WB 30K/1501 and other articles maintaining all norms and formalities.

So, I therefore pray that a case under proper section of law may kindly be started against the accused persons - (1) Uttam Kumar Maity (39 yrs) s/o Lt Kshudiram Maity; (2) Rikta Bhowmik (Maity) (34 yrs) w/o Uttam Kumar Maity both of Janakichak PS Moyna Dist Purba Medinipur and oblige.
