Sir,

In producing herewith arrested accused namely Swarnalata Maity (40 yrs) w/o Souman Kumar Maity of Harduachak PS Moyna Dist Purba Medinipur and I, SI Joydev Mondal of Moyna PS do here by lodge a written complaint against Swarnalata Maity (40 yrs) w/o Souman Kumar Maity and Soumen Maity s/o Sunii Maity @ Bankim both of Harduachak PS Moyna Dist Purba Medinipur to the effect that on 06.04.2017 at 18:35 hrs ASI Ajoy Mridha, duty officer of Moyna PS received secret information from an unknown caller who refused to disclose his identity that Swarnalata Maity w/o Souman Kumar Maity and her husband - Soumen Maity s/o Sunii Maity @ Bankim both of Harduachak PS Moyna Dist Purba Medinipur used to stock ID liquor at their shop styled as "Swarna Cabin", just adjacent to the Public waiting room at Annapurna Bazar beside Moyna - Pingla pitch road and sold to the local people in lieu of money and they are engaged such this calloustine business for a prolonged period which refers Moyna PS GDE No 243, Dated 06.04.2017.

I have been directed to work out the information and accordingly myself along with C/ 758 Tapan Samanta, C/627 Sailendranath Sarkar L/C1813 Indrani Sheet all of Moyna PS proceeded towards Annapurna Bazar who were already detailed for evening Mobile duty vide Moyna PS CC No 1002/17, Dated 06.04.2017.

On 06.04.17 at 18:55 hrs, myself accompanied with force reached a shop styled as "Swarna Cabin", just adjacent to the Public waiting room at Annapurna Bazar beside Moyna - Pingla pitch road and held raid and seeing police party some persons who were seating and consuming ID liquor (cholai) started to flee away but somehow managed to apprehend one female person by accompanied L/C and we disclosed our identity and purpose of raid and on interrogation the lady disclosed her identity as Swarnalata Maity (40 yrs) w/o Souman Kumar Maity of Harduachak PS Moyna Dist Purba Medinipur and thereafter we requested the local people to accompany us but none turned up and we also asked Swarnalata Maity to search our person but she denied and thereafter conducted search at the said shop maintaining all norms and formalities and found approx 20 (Twenty) liters ID liquor (cholai) in a plastic jerkin valued Rupees 70/- (seventy) per liter approx.(Total valued Rs 70 X 20 =Rs.1400/- approx), and asked Swarnalata Maity to produce the valid document in respect of the said articles but she failed. Then I seized those articles duly signed by the Swarnalata Maity and police witnesses, as none other person turned up on request. Sample was taken on the spot duly sealed and labeled by me. On further interrogation it could be learnt that Swarnalata Maity with her husband Soumen Maity s/o Sunil Maity @ Bankim both of Harduachak PS Moyna Dist Purba Medinipur run such type of calloustine businesses for a prolonged period and they have not any valid document or license to run this businesses.

In spite of my several request the said shop keeper Swarnalata Maity could not be able to produce the license or any valid document for selling those liquor or stock of the same and confessed that she with her husband actually stocked ID liquor (Cholai) at their said shop and used to sell the same to the local public in lieu of money illegally and continuing this illegal business since long causing loss of Govt. revenue. Hence she was taken into custody after issuing memo of arrest duly signed by her as she and her husband - Soumen Maity s/o Sunil Maity @ Bankim both of Harduachak PS Moyna Dist Purba Medinipur, violated the provision of sec 18 (I) of Bengal Excise Act and he committed an offence u/s 46 A (C) of Bengal Excise Act, 1909 and conducted further search to secure the arrest of Soumen Maity s/o Sunil Maity @ Bankim both of Harduachak PS Moyna Dist Purba Medinipur but he concealed himself to avoid arrest.

Under the above circumstances I request you to start a specific case against Swarnalata Maity (40 yrs) w/o Souman Kumar Maity and Soumen Maity s/o Sunil Maity @ Bankim both of Harduachak PS Moyna Dist Purba Medinipur and arrange for its investigation.
