Sub : Report on physical harassment with our JCB operator by security guard at site during duty hours at site on today (i.e 07.4.17) at about 5.30 P.M.

Dear sir,

We would like to inform you that we are constructing the prestigious via duct structure at Moyna under supervision of P.W(roads) Directt., Govt of West Bengal.

We have engaged security agency for guarding of the project area round the clock. One of the security guards, Sanmaj Khan, S/o Rahaman Khan, residence near Garsafat Masjid, P.O. & P.S-Moyna, Dist-Purba Medinipur, performs his duty at our office area from 6.00 P.M to 6.00 A.M. He was already warned for his diligence in his duty and no hit to none.

A casting was going on at our approach road portion on today. Suddenly at about 5.30 P.M, sanamaj Khan came to the casting site, intentionally tried to stop the work and physically harassed and teased our JCB operator 3 to 4 times by climbing on JCB. Our working labourers at once rushed to the point and take away Sanmaj Khan from the site and he left the site by using continuous slang languages. For this incident our JCB operator got very much frightened and he left the area towards our camp.

So, we would request you to take necessary steps in this regards and we would also request you to please lodge a F.I.R on the above mentioned incident.
