Sir,

In producing herewith arrested accuse namely Rabin Kar (40 yrs.) s/o Lt Rakhai Kar of Deoly, PS Moyna, Dist Purba Medinipur, (owner of illegal I.D liquor shop cum seller). I, ASI Ajoy Mridha of Moyna PS do here by lodged complaint against Rabin Kar (40 yrs) s/o Lt Rakhai Kar of Deoly, PS Moyna, Dist. Purba Medinipur, to the effect that on 25.04.17 at 18:05 hrs. SI Prasun Paria of Moyna PS received secret information that illegal sale of I.D. liquor is going on at Deoly, P.S Moyna. This has a reference to Moyna P.S. GDE No 1133 dtd. 25.04.17

I have been directed to work out the information and accordingly myself along with C/ 758 Tapan Samanta, NVF Goutam Maity both of Moyna PS who were already detailed for mobile duty vide Moyna PS C.C No 1166/17 dtd.25.04.17 left for to work out the information.

On 25.04.17 at 18:45 hrs. myself accompanied with force reached at Deoly and identified the liquor shop cum house and held raid at the liquor shop of Rabin Kar. Seeing police some persons who were seating and consuming I.D liquor started to flee away but shop owner was apprehended, it revealed that the accused Rabin Kar is selling unauthorized liquor to consumer violating the law of the land relating to such stock and sale governed in the Bengal Excise Act.

On 25.04.17 in between 18:55 hrs, to 19:25 hrs. searched the shop and found approx 07 (Seven) liters I.D. liquor (chola) in a plastic jerkin valued Rupees 70/- (Seventy) per liter approx (Total valued Rs 70 X 07 =Rs.490/- approx), which I seized duly signed by the seller and Police witnesses, and Sample was taken on the spot duly sealed and labeled by me.

In spite of my several request the said shop keeper Rabin Kar could not be able to produce the license or any valid document for selling those liquor and confessed that he actually stocked ID liquor at his house cum shop situated under Mouza Deoly and selling illegally.

On enquiry it came to learnt that Rabin Kar continuing this illegal business since long causing loss of Govt. revenue. Hence was taken into custody after issuing memo of arrest duly signed by him as he violated the provision of sec 18 (1) of Bengal Excise Act and he committed an offence u/s 46 A (C) of Bengal Excise Act, 1909.

Under the above circumstances I request you to start a specific case against Rabin Kar (40 yrs) s/o Lt. Rakhai Kar of Deoly, P.S. Moyna, Dist. Purba Medinipur (owner of the I.D liquor shop cum seller) and arrange for its investigation.
