Sir,

In producing herewith arrested accused namely(1) Uttam Sahoo (38 yrs) s/o Lt. Gurupada Sahoo of Dakshin Harkuli PS Moyna Dist Purba Medinipur (2) Joydev jana(48yrs) s/o Lt. kanailal Jana of Dakshin Harkuli PS Moyna Dist Purba Medinipur with seized articles and I, SI Joydev Mondal of Moyna PS do hereby lodge a complaint against (1) Uttam Sahoo (38 yrs) s/o Lt. Gurupada Sahoo of Dakshin Harkuli PS Moyna Dist Purba Medinipur (2) Joydev jana(48yrs) s/o Lt. kanailal Jana of Dakshin Harkuli to the effect that on 08.05.2017 at 05:15 hrs duty officer, ASI Dilip kr. Jana of Moyna PS received a secret information from an unknown caller as he refused to disclose his identity that one (1) Uttam Sahoo (38 yrs) s/o Lt. Gurupada Sahoo of Dakshin Harkuli PS Moyna Dist Purba Medinipur (2) Joydev jana(48yrs) s/o Lt. kanailal Jana of Dakshin Harkuli were selling country spirit illegally to the local people in lieu of money as usual near "Kripasindhu More Bazar near fish Market" which refers Moyna PS GDE No 294 Dated 08.05.2017 and as per direction of OC Moyna PS directed me to look into the matter immediately.

As I with C/ 555 Amit Bhowmik, C/1021 Avijit Sarkar both of Moyna PS has already been detailed for Night mobile duty vide Moyna PS CC No1282 /17, Dated 07.05.2017 with government vehicle, so we left for to work out over the said information.

On 08.05.2017 around 05:35 hrs myself with force reached near "Kripasindhu More Bazar near fish Market" and kept our vehicle a few distance from there and search for local witnesses to accompany us during raid but none were easily available and keeping in mind the source information and other factors held raid near "Kripasindhu More Bazar near fish Market and seeing police some persons who were seating and consuming liquor started to flee away but somehow we managed to apprehend a persons. Then we disclosed our identity and briefed him the purpose of raid and their apprehension and on asking he disclosed their identity as Uttam Sahoo (38 yrs) s/o Lt. Gurupada Sahoo of Dakshin Harkuli PS Moyna Dist Purba Medinipur (2) Joydev jana(48yrs) s/o Lt. kanailal Jana of Dakshin Harkuli. Then I asked them to search our person but they denied and on searching their person found 10 Bottles country Spirit each of approx 600 ml, marked as "Bindash(60 up)" and each Rs 65/- and few plastic glasses which were kept in a nylon bag and on asking to produce the valid document/papers or license in respect of those articles they failed to produce the same and further interrogation they stated that they collected those country spirit and sold the same to the local people in lieu of money violating the law of the land relating to such stock and sale. Then I seized the articles - 10 Bottles country Spirit each of approx 600 ml, marked

as "Bindashh (60up)" and each Rs 65/- (Total Value Rs 65 X 10 = Rs. 650/-) and few plastic glasses which were kept in a nylon bag from the exclusive possession of Uttam Sahoo (38 yrs) s/o Lt. Gurupada Sahoo of Dakshin Harkuli PS Moyna Dist Purba Medinipur (2) Joydev Jana (48yrs) s/o Lt. Kanailal Jana of Dakshin Harkuli preparing seizure list duly signed by witnesses and one bottle (sealed) was taken as sample on the spot duly sealed and labeled by me and took counter signature of Uttam Sahoo (38 yrs) s/o Lt. Gurupada Sahoo of Dakshin Harkuli PS Moyna Dist Purba Medinipur (2) Joydev Jana (48yrs) s/o Lt. Kanailal Jana of Dakshin Harkuli PS Moyna Dist Purba Medinipur and supplied them the copy of the same and thereafter arrested them preparing memo of arrest maintaining all norms and formalities and supplied him the copy of the same and on searching of their persons found nothing but wearing apparels.

On further enquiry it came to learn that Uttam Sahoo (38 yrs) s/o Lt. Gurupada Sahoo of Dakshin Harkuli PS Moyna Dist Purba Medinipur (2) Joydev Jana (48yrs) s/o Lt. Kanailal Jana of Dakshin Harkuli Dist Purba Medinipur is continuing this calloustne illegal business since long causing loss of Govt. revenue. Hence were taken into custody after issuing memo of arrest duly signed by them as he violated the provision of sec 18 (1) of Bengal Excise Act and they committed an offence u/s 46 A (C) of Bengal Excise Act, 1909.

Under the above circumstances I request you to start a specific case against Uttam Sahoo (38 yrs) s/o Lt. Gurupada Sahoo of Dakshin Harkuli PS Moyna Dist Purba Medinipur (2) Joydev Jana (48yrs) s/o Lt. Kanailal Jana of Dakshin Harkuli (owner of the country spirit liquor seller) and arrange for its investigation.
