Dear Sir,

I do hereby lodged complaint, empowered by the electricity act 2003 to the effect that Sri Prafullya Maiti, S/O- Lt.Beharilal Maiti, vill,- Paramanadapur, P.S. –Moyna, Dist – Purba Medinipur, has committed theft of electricity u/s 135 of the Electricity Act 2003 read with amendment Act 2007 as stated hereunder.

On 12.05.2017 at 01:40 p.m, I, Sri Dibyendu Sekhar Bhunia, DE & S&LP along with (1) Sri Abhijit Das, AE&SM, Moyna CCC, (2) Sri Partha Kolay, SAE(E), Moyna CCC (3) Sri Madhab Ch. Manna, LM Regional Office and other officials had been into the village Paramanadapur for inspection purpose. At first we visited the domestic premises of consumer named Sri Prafullya Maiti vide reference ID no – 222082096 and meter no – B1191623. During inspection it was found that Sri Prafullya Maiti was consuming power dishonestly by way direct hooking from nearby LT overhead line bypassing the meter for less recording of energy meter for wrongful gain, thereby causing loss of WBSEDCL's revenue. On physical verification the assessed load was detected 2 KVA.

As theft of electricity was detected during inspection before seizure the service connection of the consumer was disconnected with removal of the unauthorized hooking wire and thereafter some portion of unauthorized wire single core PVC wire red color 3 meters approx. and one yellow card SL No: 0412230 in the name of Prafullya Maiti were seized under a memo of seizure list. The said seized wire was utilized for theft in respect of power. I also prepared an inspection report at site. Before leaving the area, it was asked from the accused person to sign on the seizure list and inspection report but he refused to do so.

The above seized materials were duly packed, labeled at the inspection site and signature of the witnesses obtained on the label. The inspection team left the premises at 2:00 pm.

Thus the accused person that Sri Prafullya Maiti S/O- Lt.Beharilal Maiti, Vill,- Paramanadapur, P.S. –Moyna, Dist – Purba Medinipur, has committed an offence u/s 135(1)(b) of the Electricity Act 2003 read with amendment Act 2007 under the per view of theft in respect of electricity of WBSEDCL.

You are requested to take cognizance of this complaint and treat it as FIR.
