Dear Sir,

I do hereby lodged complaint, empowered by the electricity act 2003 to the effect that Sri Haripada Bhoumik, S/O- Lt. Pashupati Bhoumik, vill,- Changra, P.S. –Moyna, Dist – Purba Medinipur, has committed theft of electricity u/s 135 of the Electricity Act 2003 read with amendment Act 2007 as stated hereunder.

On 17.05.2017 at 12.40 p.m, I, Sri Abhijit Das, AE & SM, Moyna CCC alongwith (1) Sri Partha Kolay, SAE(E), Moyna CCC (2) Sri Gouri Sankar Mahapatra, HG. LM and other officials, all of Moyna CCC, WBSEDCL had been into the village Changra for inspection purpose. At first we visited the agriculture premises of named Sri Haripada Bhoumik. During inspection it was found that Sri Haripada Bhoumik was consuming power dishonestly by way of direct hooking from the LT mains by running a motor for wrongful gain, thereby causing loss of WBSEDCL's revenue. On physical verification the assessed load was detected 1.0 HP.

As theft of electricity was detected during inspection before seizure, we removed the unauthorized wire from pole then seized some portion of unauthorized hooking wire single core PVC wire Black color with hooking device 3 meters approx. under a memo of seizure list in presence of the witnesses and duly signed by the witnesses. The said seized wire was utilized for theft in respect of power. I also prepared an inspection report duly signed by witnesses. It was asked to the accused person regarding his residential and identity proof but he refused to provide the same as well as refused to sign on the seizure list and inspection report. On local enquiry it is learnt that agriculture premises is belong to him.

The above wire was duly packed, labeled at the inspection site and signature of the witnesses obtained on the label. The inspection team left the premises at 01.10 pm.

Thus the accused person that Sri Haripada Bhoumik S/O- Lt. Pashupati Bhoumik, Vill,- Changra, P.S. –Moyna, Dist – Purba Medinipur, has committed an offence u/s 135(1)(a) of the Electricity Act 2003 read with amendment Act 2007 under the per view of theft in respect of electricity of WBSEDCL.

You are requested to take cognizance of this complaint and treat it as FIR.
