In producing herewith arrested accused namely (1) Sanjoy Dhal (36 yrs) s/o Sasanka Dhal of Kiarana PS Moyna Dist Purba Medinipur (2) Gopal Bhunia @Bachhan (28 yrs) s/o Bholanath Bhunia of Kiarana PS Moyna Dist Purba Medinipur with seized articles and I, SI Pranab Samanta of Moyna PS do hereby lodge a complaint against (1) Sanjoy Dhal (36 yrs) s/o Sasanka Dhal of Kiarana PS Moyna Dist Purba Medinipur (2) Gopal Bhunia @Bachhan (28 yrs) s/o Bholanath Bhunia of Kiarana to the effect that on 06.06.2017 at 19:15 hrs duty officer, ASI Ashim Mukharjee of Moyna PS received a secret information from an unknown caller as he refused to disclose his identity that one (1) Sanjoy Dhal (36 yrs) s/o Sasanka Dhal of Kiarana PS Moyna Dist Purba Medinipur (2) Gopal Bhunia @Bachhan (28 yrs) s/o Bholanath Bhunia of Kiarana were selling country spirit illegally to the local people in lieu of money as usual beside Moyna- Balaipanda Pitch Road near Laxmi Bani mill approx 20- Mtr. South West from Bright Gust House Under Mouza Paramanandapur" which refers Moyna PS GDE No 264 Dated 06.06.2017 and as per direction of OC Moyna PS directed me to work out the information immediately.

As I with C/ 627 Sailandranath Sarkar, C/1021 Avijit Sarkhel both of Moyna PS has already been detailed for Noon mobile duty vide Moyna PS CC No 1537/17, Dated 06.06.2017 with government vehicle, so we left for Paramanandapur to work out the said information.

On 06.06.2017 around 21:05 hrs myself with force reached On Moyna - Balaipanda Pitch Road near Laxmi Bani mill (prof. Bhim Mondal) Under Mouza Paramanandapur and kept our vehicle a few distance from there and search for local witnesses to accompany us during raid but none were easily available and keeping in mind the source information and other factors held raid near name and style Laxmi Bani Mill under Mouza Paramanandapur and seeing police some persons who were seating and consuming liquor( Country Spirit) started to flee away but some how we managed to apprehend two persons. Then we disclosed our identity and briefed them the purpose of raid and their apprehension and on asking he disclosed their identity as (i) Sanjoy Dhal (36) s/o Sasanka Dhal (ii) Gopal Bhunia @Bachhan (28) s/o Bholanath Bhunia both of vill- Kiaran PS Moyna, Dist. Purba Medinipur. Then I asked them to search our person but they denied and on searching their person found 10 Bottles country Spirit each of 600 ml, marked as "Sun( 60 up)" and each Bottle value of Rs 65/- and twenty Bottles marked "Bindas" (.60 UP)and each Bottle 600 ml and each value of Rs, 55 /-and few plastic glasses which were kept in two old big Lylon bag in a Motor Cycle bearing No.WB 30T1083 (Mahindra) and on asking them to produce the valid document/papers or license in respect of those articles and valid documents of Motor cycle bearing regd. No WB -30T/1083 but they failed to produce any valid documents or license for running
