Sir,

In producing herewith arrested accused namely Pulin Maity @ Bhutu @ Bablu (50yrs) s/o Laxman Maity of Kripanandapur PS Moyna Dist Purba Medinipur with seized articles and I, ASI Ashim Mukharjee of Moyna PS do hereby lodge a complaint against Pulin Maity@ Bhutu @ Bablu (50yrs) s/o Laxman Maity of Kripanandapur P.S Moyna Dist Purba Medinipur to the effect that on 24.06.2017 at 16:25 hrs duty officer, ASI Dilip Kr. Jana of Moyna PS received a secret information from an unknown caller as he refused to disclose his identity that one Pulin Maity (50yrs) s/o Laxman Maity of Kripanandapur in habitant of Kripanandapur under PS Moyna was selling country spirit illegally to the local people in lieu of money as usual at Sridharpur Bazar refers Moyna PS GDE No 1136, Dated 24.06.2017 and as per direction of OC Moyna PS directed me to look into the matter immediately.

As I with C/627 Sailendranath Sarkar , C/ 710 Dipak Ramjan Roy both of Moyna PS has already been detailed for mobile duty vide Moyna PS CC No 1729/17, Dated 24.06.2017 with government vehicle, so we left for to work out over the said information.

On 24.06.2017 around 17:05 hrs myself with force reached Sridharpur Bazar and kept our vehicle a few distance from there and search for local witnesses to accompany us during raid but none were easily available and keeping in mind the source information and other factors held raid selling Place of Pulin Maity@ Bhutu @ Bablu of Kripanandapur and seeing police some persons who were seating and consuming liquor started to flee away but somehow we managed to apprehend a person. Then we disclosed our identity and briefed him the purpose of raid and his apprehension and on asking he disclosed his identity as Pulin Maity (50yrs) s/o Laxman Maity of Kripanandapur, PS Moyna Dist Purba Medinipur. Then I asked him to search our person but he denied and on searching him found 35 Bottles country Spirit each of 600 ml, marked as " Sun " and each Rs 65/- which were kept in a nylon bag and on asking to produce the valid document/papers or license in respect of those articles he failed to produce the same and further interrogation he stated that he collected those country spirit and sold the same to the local people in lieu of money violating the law of the land relating to such stock and

sale. Then I seized the articles 35 Bottles country Spirit each of 600 ml, marked as "Sun " and each Rs 65/- (Total Value Rs 65 X 35 =Rs. 2275/-) were kept in a nylon bag from the exclusive possession of Pulin Maity Bhutu @ Bablu (50yrs) s/o Laxman Maity of Kripanandapur P.S Moyna Dist. Purba Medinipur, preparing seizure list duly signed by witnesses and one Bottle (sealed) was taken as sample on the spot duly sealed and labeled by me and took counter signature of Pulin Maity @ Bhutu @ Bablu (50yrs) s/o Laxman Maity of Kripanandapur P.S Moyna Dist Purba Medinipur and supplied him the copy of the same and thereafter arrested him preparing memo of arrest maintaining all norms and formalities and supplied him the copy of the same and on searching of his person found nothing but wearing apparels.

On further enquiry it came to learn that Pulin Maity @ Bhutu @ Bablu (50yrs) s/o Laxman Maity of Kripanandapur P.S Moyna Dist Purba Medinipur is continuing this callous tine illegal business since long causing loss of Govt. revenue. Hence was taken into custody after issuing memo of arrest duly signed by him as he violated the provision of sec 18 (I) of Bengal Excise Act and he committed an offence u/s 46 A (C) of Bengal Excise Act,1909.

Under the above circumstances I request you to start a specific case against Pulin Maity @ Bhutu @ Bablu(50yrs) s/o Laxman Maity of Kripanandapur P.S Moyna , Dist. Purba Medinipur (owner of the country spirit liquor seller) and arrange for its investigation.
