I, SI Md Mahiul Islam, OC Moyna PS along with SI Prasun Paria, SI Joydev Mondal, SI Pranab Samanta, ASI Dilip Kumar Jana, ASI Ashim Mukharjee, ASI Ajay Mridha, C/ 555 Amit Bhowmik, C/ 206 Birendrnath Saha, C/ 554 Sidhartya Chakraborty, C/ 627 Sailendrnath Sarkar, C/ 1247 Badal Pachal, C/ 1486 Goutam Kumar Nandi, SAP C/ 242 Ramprasad Bisai, SAP C/ 344 Suraj Singh, SAP 153 Shyamchand Hansda, NVF Goutam Maity, LC/ 1766 Yamuna Barman, LNVF Meghna Maity, LHG Sita Baag and other VPs and CVs return PS from Prajabarh village under Srikantha GP (GP No III), JL No 170, PS Moyna, Dist Purba Medinipur after performing an L/O duty and lodged a complaint as suo-moto against the 100/150 unknown people to the effect that a prolonged communal tension was prevailing in between the Muslim community people and Hindu community people over the construction work of a guard wall and its boundary on a canal was going on at village Prajabarh just beside of Hoglabari to Prajabarh pitch road (right side) here is khas land just the adjacent of black-top of the said road and thereafter there is a canal and then there is the land of the people of the Muslim Community. In several occasion steps were being taken to solve the problem.

Later on 27.06.2017 at about 8:35 hrs received a telephonic information from an unknown caller as he refused to disclose his identity that the Muslim community people started construction work on the canal at village Prajabarh (just beside of Hoglabari to Prajabarh pitch road then there is khas land just the adjacent of black-top of the said road and thereafter there is a canal) and the Hindu community people are started to assemble to restrained the Muslim community people to stop the said construction work there and a communal tension has already prevailed and this may cropped up a communal riot and every chance of serious breach of peace and at any time a commotion could be taken place at the area over this burning communal sentiment. I diarized the matter in GD vide Moyna PS GDE No 1653, Dated 27.06.2017 and arrange to inform zonal superiors - CI Nandakumar, SDPO Tamluk, SP Purba Medinipur for further re-enforcement and also communicated the entire fact and its ultimatum to BDO, Moyna and requested him to accompany us to act as an executive magistrate to guide us keeping in view the gravity of this incident.

I along with the above noted officers and force of Moyna PS and available VPs and CVs left for the PO by government vehicle bearing 1) WB 42 S /1513; (2) WB 30 B / 1007 and informed other VPs and CVs to rushed to spot. BDO Moyna Block also accompanied us with his government vehicle vide registration no WB 29 G / 0718 to rush the spot.

On arrival there we found that near about 100/150 people each from the Muslim community and Hindu community assembled in two groups who were in agitated mood comprising with female and children with male person. We tried to dispersed them and started to negotiate with both parties to disperse them on the spot but all of a sudden the assembled 100/150 unknown people of the Hindu community armed with lathi, stones obstructed the Hoglabari - Prajabarh started sound of conches and started to proceed towards the canal side where the Muslim community people gathered with abusive languages in violent mood to dismantle off the newly constructed guard wall. In the meanwhile Police made a barricade to prevent the Hindu community people to proceed there then I and BDO Moyna Block warned the unruly people of the Hindu community not to do so but they paid no heed us and having no other alternative way they were declared as unlawful assembly. Then the unlawful assembly of 100/150 Hindu community people

started to pelting stone, brick bats upon Police party and towards the Muslim community people and broke two government vehicle. As a result (i) ASI Ashim Mukherjee, (ii) C/554 Sidhartya Chakraborty, (iii) CV Samir Kumar Gunri; (iv) CV Prasanta Das; (v) CV Prasanta Hazra sustained injuries along with some persons of Muslim community people and after light lathi charge however they could be dispersed.

Then I seized the two damaged government vehicle having registration no 1) 1) WB 42 S /1513; (2) WB 29 G / 0718, broken glasses of that two vehicles separately and left the same to zimmanama and also seized some pieces of brick bats, stones, sticks etc.

A huge tension is prevailing in between two communities, so placed picket duty there and briefed them properly.

Over this registered Moyna PS Case No 276/17, Dated 27.06.2017, u/s 147/148/149/323/325/307/332/333/352/353/427/431 IPC, 3/4 PDPP Act and 9 MPO Act, as suo-moto, against 100/150 unknown people.
