Sir,

In producing herewith arrested accuse namely Gurupada Shit (60 Yrs) s/o Lt. Sudhakrishna @ Sudha Kistha Shit of Uttampur, P.S. Moyna, Dist. Purba Medinipur, (owner of illegal I.D liquor shop cum seller). I, SI. Joydev Mondal of Moyna P.S. do here by lodged complaint against Gurupada Shit (60 Yrs) s/o Lt. Sudhakrishna @ Sudha Kistha Shit of Uttampur, P.S. Moyna Dist Purba Medinipur, to the effect that on 03.01.17 at 16:55 hrs. ASI Ajoy Mridha duty officer of Moyna P.S. received secret information that, illegal sale of I.D.liquor is going on at Uttampur GP area under Moyna P.S. This has a reference to Moyna P.S. GDE No 101 dtd.03.01.17.

I have been directed to work out the information and accordingly myself along with SAP C/ 41 Nityananda Mondal SAP C/ 26 Mithun Das (SAP 11 Bn.) both of Moyna P.S who were already detailed for evening mobile duty vide Moyna P.S.C.C No.20/17 dated 03.01.17 left for to work out the information.

On 03.01.17 at 17:35 hrs. myself accompanied with force reached at Uttampur and identified the house cum liquor shop and held raid at the liquor shop of Gurupada Shit. Seeing police some persons who were seating and consuming I.D liquor (cholai) started to flee away but shop owner was apprehended, It revealed that the accused Gurupada Shit is selling unauthorized liquor (Cholai) to consumer violating the law of the land relating to such stock and sale governed in the Bengal Excise Act.


On 03.01.17 in between 17:40 hrs. to 18:00 hrs. searched the shop and found approx 10 (ten) liters I.D. liquor (cholai) in a plastic jerkin valued rupees 70/- (seventy) per liter approx.(Total valued Rs 70X10 =Rs.700/- approx), which I seized duly signed by the seller and Police witnesses, as no local public person turned up on request. Sample was taken on the spot duly sealed and labeled by me.

In spite of my several request the said shop keeper Gurupada Shit could not be able to produce the license or any valid document for selling those liquor and confessed that he actually stocked ID liquor (Cholai) at his house cum I.D Liquor shop under Mouza Uttampur P.S Moyna and selling illegally. Gurupada Shit continuing this illegal business since long causing loss of Govt. revenue. Hence was taken into custody after issuing memo of arrest duly signed by him, as he violated the provision of sec 18 (I) of Bengal Excise Act and he committed an offence u/s 46 A (C) of Bengal Excise Act, 1909.

Under the above circumstances I request you to start a specific case against Gurupada Shit (60 Yrs) s/o Lt. Sudhakrishna Shit of Uttampur,, P.S. Moyna, Dist. Purba Medinipur (owner of the I.D liquor shop cum seller) and arrange for its investigation.
