In producing herewith arrested accuse namely 1) Ajit Das (54 Yrs) s/o Lt. Surya Das of Sudampur, 2) Sunil Maity (50 yrs) s/o Lt. Radhagobinda of Paramanandapur (3) Narayan Pattanayek (56) s/o Lt Adwitya Pattanayek Uttarchangra chak all of P.S. Moyna , Dist. Purba Medfinipur, (owner of illegal I.D liquor shop cum seller). I, SI. Prasun Paria of Moyna P.S. do here by lodged complaint against 1) Ajit Das (54 Yrs) s/o Lt. Surya Das of Sudampur, 2) Sunil Maity (50 yrs) s/o Lt. Radhagobinda of Paramanandapur (3) Narayan Pattanayek (56) s/o Lt Adwitya Pattanayek of Uttarchangrachak all of P.S. Moyna , Dist. Purba Medfinipur, to the effect that on 03.01.17 at 16:20 hrs. ASI Ajoy Mridha duty officer of Moyna P.S. received secret information that, illegal sale of I.D.liquor is going on at Paramanandapur GP area under Moyna P.S. This has a reference to Moyna P.S. GDE No 97 dtd.03.01.17.

I have been directed to work out the information and accordingly myself along with C/ 1247 Badal Pachal C/ 1486 Goutam Nandi C/959 Jayanta Barman all of Moyna P.S who were already detailed for evening mobile duty vide Moyna P.S.C.C No.16/17 dated 03.01.17 left for to work out the information.

On 03.01.17 at 17:00 hrs. myself accompanied with force reached at Uttarchangrachak and identified the house cum liquor shop and held raid at the liquor shop of Narayan Pattanayek. Seeing police some persons who were seating and consuming I.D liquor (cholai) started to flee away but shop owner was apprehended, It revealed that the accused Narayan Pattanayek is selling unauthorized liquor (Cholai) to consumer violating the law of the land relating to such stock and sale governed in the Bengal Excise Act.

On 03.01.17 in between 17:05 hrs. to 17:25 hrs. searched the shop and found approx 10 (ten) liters I.D. liquor (cholai) in a plastic jerkin valued rupees 70/- (seventy) per liter approx.(Total valued Rs 70X10 =Rs.700/- approx), which I seized and duly signed by the seller and Police witnesses, as no local public person turned up on request. Sample was taken on the spot duly sealed and labeled by me.

On 03.01.17at 17:40 hrs. myself accompanied with force reached at Paramanandapur and identified the house cum liquor shop Sunil Maity (50 yrs) s/o Lt. Radhagobinda of Paramanandapur and held raid at the liquor shop. Seeing police some persons who were seating and consuming I.D liquor (cholai) started to flee away but shop owner was apprehended, It revealed that the accused Sunil Maity is selling unauthorized

liquor (Cholai) to consumer violating the law of the land relating to such stock and sale governed in the Bengal Excise Act.

On 03.01.17 in between 17:45 hrs. to 18:05 hrs. searched the shop and found approx 15 (fifteen) liters I.D. liquor (cholai) in two plastic jerkin valued rupees 70/- (seventy) per liter approx.(Total valued Rs 70X15 =Rs.1050/- approx), which I seized and duly signed by the seller and Police witnesses, as no local public person turned up on request. Sample was taken on the spot duly sealed and labeled by me

On 03.01.17 at 18:25 hrs. myself accompanied with force reached at Paramanandapur Majher Bandh and identified the house cum liquor shop Ajit Das (50 yrs) s/o Lt Surya Das of sudampur and held raid at the liquor shop. Seeing police some persons who were seating and consuming I.D liquor (cholai) started to flee away but shop owner was apprehended, It revealed that the accused Ajit Das is selling unauthorized liquor (Cholai) to consumer violating the law of the land relating to such stock and sale governed in the Bengal Excise Act

On 03.01.17 in between 18:35 hrs. to 18:55 hrs. searched the shop and found approx 12 (twelve) liters I.D. liquor (cholai) in a plastic jerkin valued rupees 70/- (seventy) per liter approx.(Total valued Rs 70X12 =Rs.840/- approx), which I seized and duly signed by the seller and Police witnesses, as no local public person turned up on request. Sample was taken on the spot duly sealed and labeled by me


In spite of my several request the said shop keeper, 1) Ajit Das (54 Yrs) s/o Lt. Surya Das of Sudampur, 2) Sunil Maity (50 yrs) s/o Lt. Radhagobinda of Paramanandapur (3) Narayan Pattanayek (56) s/o Lt Adwitya Pattanayek Uttarchangra chak all of P.S. Moyna , Dist. Purba Medfinipur, could not be able to produce the license or any valid document for selling those liquor and confessed that they actually stocked ID liquor (Cholai) at their houses cum I.D Liquor shops under Mouza Sudampur , Paramanandapur, and Uttarchangrachak respectively under P.S Moyna and selling illegally. All are continuing this illegal business since long causing loss of Govt. revenue. Hence they were taken into custody after issuing memo of arrest duly signed by them , as they violated the provision of sec 18 (I) of Bengal Excise Act and he committed an offence u/s 46 A (C) of Bengal Excise Act, 1909.

Under the above circumstances I request you to start a specific case against 1) Ajit Das (54 Yrs) s/o Lt. Surya Das of Sudampur, 2) Sunil Maity (50 yrs) s/o Lt. Radhagobinda of Paramanandapur (3) Narayan Pattanayek (56) s/o Lt Adwitya Pattanayek of Uttarchangrachak all of P.S. Moyna , Dist. Purba Medfinipur, (owner of the I.D liquor shop cum seller) and arrange for its investigation.
