Dear Sir,

I do hereby lodged complaint, empowered by the electricity act 2003 to the effect that Sri Srikanta Bhowmik, S/O- Lt.Benimadhab Bhowmik, vill,- Sudampur, P.S. –Moyna, Dist – Purba Medinipur, has committed theft of electricity u/s 135 of the Electricity Act 2003 read with amendment Act 2007 as stated hereunder.

On 15.03.2017 at 12.05 p.m, I, Sri Abhijit Das, AE & SM, Moyna CCC alongwith (1) Sri Aniruddha Pradhan, S.E(E), S&LP, Vidyut Bhavan (2) Sri Dibyendu Sekhar Bhunia, DE & S&LP (3) Sri Bappaditwa Samanta, AE, S&LP, Vidyut Bhavan (4) Sri Taraknath Masonta, S&LP, Vidyut Bhavan, (5) Sri Jiban Sankar Niyogi, SO, RM Office, Tamluk, (6) Sri Partha Kolay, SAE(E), Moyna CCC (7) Sri Pankaj Kr. Das, HG. TSH and other officials had been into the village Sudampur for inspection purpose. At first we visited the domestic premises of consumer named Sri Srikanta Bhowmik vide reference ID no – 222229658 and meter no – L4685975. During inspection it was found that Sri Srikanta Bhowmik was consuming power dishonestly by way direct hooking from nearby LT overhead line bypassing the meter for less recording of energy meter for wrongful gain, thereby causing loss of WBSEDCL's revenue. On physical verification the assessed load was detected 1.0 KW.

As theft of electricity was detected during inspection at first before seizure the service connection of the consumer was disconnected with removal of the unauthorized hooking wire and thereafter some portion of unauthorized wire single core PVC wire black color 5 meters approx. and one yellow card SL No: 1345637 in the name of Sri Srikanta Bhowmik were seized under a memo of seizure list in presence of the witnesses named Sulekha Bhowmik w/o Sri Srikanta Bhowmik and duly signed by the mentioned witnesses on it. The said seized wire was utilized for theft in respect of power. I also prepared an inspection report at site duly signed by witnesses named Sulekha Bhowmik w/o Sri Srikanta Bhowmik on it.

The above wire was duly packed, labeled at the inspection site and signature of the witnesses obtained on the label. The inspection team left the premises at 12.30 pm.

Thus the accused person that Sri Srikanta Bhowmik S/O- Lt.Benimadhab Bhowmik, Vill,- Sudampur, P.S. –Moyna, Dist – Purba Medinipur, has committed an offence u/s 135(1)(b) of the Electricity Act 2003 read with amendment Act 2007 under the per view of theft in respect of electricity of WBSEDCL.

You are requested to take cognizance of this complaint and treat it as FIR.
