Sir,

In producing herewith arrested accuse namely Ekadashi Singha (43Yrs) s/o Lt Rakhal Ch. Singha of Purba Dakshin Moyna ( Panchpukuria ) P.S. Moyna Dist, Purba Medinipur, (owner of illegal I.D liquor shop cum seller . I ASI Ashim Mukherjee. of Moyna P.S. do here by lodged complaint against Ekadashi Singh (43Yrs) s/o Lt Rakhal Ch. Singh of Purba Dakshin Moyna ( Panchpukuria ), P.S. Moyna Dist Purba Medinipur, to the effect that on 22.03.17 at 18:15 hrs. SI Paresh Ch. Samanta duty officer of Moyna P.S. received secret information that, illegal sale of I.D liquor is going on at Purba dakshin Moyna ( panchpukuria ) area under Moyna P.S. This has a reference to Moyna P.S. GDE No 925 dtd.22.03.17.

I have been directed to work out the information and accordingly myself along with C/ 1486 Goutam Nandi, C/555 Amit Bhowmik both of Moyna P.S who were already detailed for evening Mobile duty vide Moyna P.S. C.C No. 768/17 dated 22.03.17 left for to work out the information.

On 22.03.17 at 18:35 hrs, myself accompanied with force reached at Purba dakshin Moyna ( panchpukuria ) and identified the house cum liquor shop and held raid at the liquor shop of Ekadashi Singha. Seeing police some persons who were seating and consuming I.D liquor (cholai) started to flee away but shop owner was apprehended, It revealed that the accused Ekadashi Singha is selling unauthorized liquor (Cholai) to consumer violating the law of the land relating to such stock and sale governed in the Bengal Excise Act.

On 22.03.17 in between 18:50 hrs, to 19:35 hrs. searched the shop and found approx 10 (ten) liters I.D. liquor (cholai) in a plastic jerkin valued Rupees 60/- (sixty) per liter approx.(Total valued Rs 60 X 10 =Rs.600/- approx), which I seized duly signed by the seller and Police witnesses, as no local public person turned up on request. Sample was taken on the spot duly sealed and labeled by me.

In spite of my several request the said shop keeper Ekadashi Singha could not be able to produce the license or any valid document for selling those liquor and confessed that he actually stocked ID liquor (Cholai) at his house cum I.D Liquor shop under Mouza Purba Dakshin Moyna ( Panchpukuria ) PS Moyna and selling illegally. Ekadashi Singha continuing this illegal business since long causing loss of Govt. revenue. Hence was taken into custody after issuing memo of arrest duly signed by him , as he violated the provision of sec 18 (I) of Bengal Excise Act and he committed an offence u/s 46 A ( C ) of Bengal Excise Act, 1909.

Under the above circumstances I request you to start a specific case against Ekadashi Singha (43Yrs) s/o Lt Rakhal Ch. Singha of Purba Dakshin Moyna ( Panchpukuria ), P.S. Moyna , Dist. Purba Medinipur (owner of the I.D liquor shop cum seller) and arrange for its investigation.
