Dear Sir,

I do hereby lodged complaint, empowered by the electricity act 2003 to the effect that Sri Siburoy, S/O- Rabi Roy, vill,- Donachak, P.S. –Moyna, Dist – Purba Medinipur, has committed theft of electricity u/s 135 of the Electricity Act 2003 read with amendment Act 2007 as stated hereunder.

On 15.03.2017 at 01.00 p.m, I, Sri Abhijit Das, AE & SM, Moyna CCC alongwith (1) Sri Aniruddha Pradhan, S.E(E), S&LP, Vidyut Bhavan, (2) Sri Dibyendu Sekhar Bhunia, DE & S&LP (2) Sri Bappaditwa Samanta, AE, S&LP, Vidyut Bhavan (3) Sri Taraknath Masonta, S&LP, Vidyut Bhavan, (4) Sri Jiban Sankar Niyogi, SO, RM Office, Tamluk, (5) Sri Partha Kolay, SAE(E), Moyna CCC (6) Sri Pankaj Kr. Das, HG. TSH and other officials, all of Moyna CCC, WBSEDCL had been into the village Donachak for inspection purpose. At first we visited the commercial fishery premises of named Sri Siburoy. During inspection it was found that Sri Siburoy was consuming power dishonestly by way of direct hooking from the LT mains for wrongful gain, thereby causing loss of WBSEDCL's revenue. On physical verification the assessed load was detected 0.50 KW.

As theft of electricity was detected during inspection at first before seizure, we removed the unauthorized wire from pole then seized some portion of unauthorized hooking wire single core PVC wire White color with hooking device 5 meters approx. under a memo of seizure list in presence of the witnesses and duly signed by the witnesses. The said seized wire was utilized for theft in respect of power. I also prepared an inspection report duly signed by witnesses.

The above wire was duly packed, labeled at the inspection site and signature of the witnesses obtained on the label. The inspection team left the premises at 01.20 pm.

Thus the accused person that Sri Siburoy S/O- Rabi Roy, Vill,- Donachak, P.S. – Moyna, Dist – Purba Medinipur, has committed an offence u/s 135(1)(a) of the Electricity Act 2003 read with amendment Act 2007 under the per view of theft in respect of electricity of WBSEDCL.

You are requested to take cognizance of this complaint and treat it as FIR.
