Dear Sir,

I do hereby lodged a complaint empowered by the electricity Act 2003 read with amendment act 2007 to the effect that Subodh Dinda S/o-Chintamani Dinda Vill.-Kamalpur P.S-Nandigram Dist- Purba Mednipur has committed theft of electricity u/s 135 of the Electricity Act 2003 read with amendment act 2007 as stated here under.

On 04.04.2017 at about 01.45 pm I,Sri Shyamsundar Mondal AE(E) & SM,Nandigram CCC along with Manik Pal (SAE),Uttam Kumar Maiti (LM),Manik Lal Maity(Sr. TSH) all of Nandigram CCC with other official entered to the agriculture premises of Subodh Dinda S/o-Chintamani Dinda Vill.-Kamalpur P.S.-Nandigram Dist- Purba Mednipur and during inspection it was found that Subodh Dinda S/o-Chintamani Dinda has got one energy meter bearing meter no-RSX83957 & Con ID-201454210, But instead of that he was consuming electricity dishonestly by way of direct hooking from nearest LT mains for bypass the energy to energy meter for less recording of energy to run his agriculture premises causing loss of revenue to WBSEDCL to the tune of load 4.38 KVA.

As the Theft was detected during the inspection, at first the service connection was disconnected and removed the unauthourised hooking cable from L.T Mains and thereafter some portion of hooking cable red and white color single core each PVC cable with hooking portion 3mtr. each Approximate was seized under a memo of seizure list in presence of witnesses and obtained their signature on the seizure list accordingly. Above seizure articles duly packed, labeled and then the signature of the witnesses also obtained on it. I also prepared an inspection report at site with duly signed by witnesses. After completion, the inspection team left the premises at 02.05 pm.

Thus the accused Subodh Dinda S/o-Chintamani Dinda Vill.-Kamalpur P.S.-Nandigram Dist-Purba Mednipur has committed an offence under section 135(i)(b) of the electricity act 2003 read with amendment act 2007 in view of theft of electricity through direct hooking for less recording of energy for his wrongful gain.

So you are requested to take cognizance of this complaint and treat it as FIR. This FIR is typed by me.
