Dear Sir,

I do hereby lodged a complaint empowered by the electricity Act 2003 read with amendment act 2007 to the effect that Sk.Sattar S/o-Lt.Sk.Ajij Vill.-Naynan P.S.-Nandigram Dist- Purba Medinipur has committed theft of electricity u/s 135 of the Electricity Act 2003 read with amendment act 2007 as stated here under.

On 12.04.2017 at about 01.50 pm I, Sri Shyamsundar Mondal AE(E) & SM, Nandigram CCC along with Manik Pal (SAE), Uttam Kr Maity (LM), Manik Lal Maity (Sr.TSH) all of Nandigram CCC with other official entered to the domestic premises of Sk.Sattar S/o-Lt.Sk.Ajij Vill.-Naynan P.S.-Nandigram Dist- Purba Medinipur and during inspection it was found that Sk.Sattar S/o-Lt.Sk.Ajij Vill.-Naynan was consuming electricity dishonestly by way of direct hooking arrangement from nearest LT mains to run the domestic premises to the tune load of 0.5 KVA causing loss of revenue to WBSEDCL.

As the Theft was detected during the inspection, the unauthorized hooking cable was disconnected and removed from LT Mains and thereafter some portion of hooking cable black color two core 2 mtr. approximate was seized under a memo of seizure list in presence of witnesses and obtained their signature on the seizure list accordingly. Above seizure articles duly packed, labeled and then the signature of the witnesses also obtained on it. I also prepared an inspection report at site with duly signed by witnesses. I also approached to Sk. Sattar to sign on the seizure list and inspection report but he refused to sign on it and I also demanded to show his documentary evidence regarding ownership of the house but he denied to show it. But it is learnt from local enquiry that the house belongs to Sk.Sattar S/o-Lt.Sk.Ajij. After completion, the inspection team left the premises at 02.10 pm.

Thus the accused Sk.Sattar S/o-Lt.Sk.Ajij Vill.-Naynan P.S.-Nandigram Dist- Purba Medinipur has committed an offence under section 135(i)(a) of the electricity act 2003 read with amendment act 2007 in view of theft of electricity through direct hooking for less recording of energy for his wrongful gain.

So you are requested to take cognizance of this complaint and treat it as FIR.
