The Complainant says to submit:-

- 1) That the complainant is a law abiding person.
- 2) That accused persons are dangerous in nature.
- 3) That in Plot no.-111 there is a house of your petitioner and the accused persons have no right title over the land. Inspite of that the accused persons intentionally restrained your petitioner and tried to grab the land and for this a civil case was instituted against the accused Prabodi Kiri and in that T.S.O.-83/2015 injunction was allowed and on 20/1/17 ~~extarx~~ the Lt. Civil Judge passed order ~~extarx~~ in favour of the complainant for repairing your petitioner's house.
- 4) That on 09/03/17 when the labourers were working, the accused persons forcibly entered into the plot and damage the house in being protest the accused persons assaulted your petitioner's wife and my daughter and also snatched the necklace of your complainant's daughter.

The value of the necklace is worth of ₹ 30,000/-

- 5) That the complainant clarified the matter at Nadigras P.S. but no effect. Then finding no way the complainant informed to S.P. Purba Medinipur on 14/03/2017.
- 6) That knowing the fact of I.O. the accused persons on 18/3/17 confined your petitioner in his way to market at about 1 AM and assaulted with fist and blow ^{about} ₹ 500/- from my pocket and created pressure for with drawing the I.O.
