Dear Sir,

As per my logged a complaint registered by the electricity Act 2003 read with Amendment Act 2007 to the effect that Sk. Ajju Rahaman S/o Lt. Sk. Rakhal Vill-7 Panjaica P.S.-Nandigram Dist. Purba Medinipur has committed theft of electricity u/s 135 of the Electricity Act 2003 read with amendment act 2007 as stated here under.

On 17.03.2017 at about 01:25 pm Mr. Sri Shamsunder Mondal Ad. & Station Manager along with Mr. Dibyendu Sekhar Bhunia D.E(S&L) Purba Medinipur Regional office, J.S. Nayak S.O. Purba Medinipur Regional office, Madhab Chand Dasgupta LPA Purba Medinipur Regional office, Mr. Ankur Dasgupta, Tapas Barua (TSH) of Nandigram CCO with other official entered to the domestic premises of Sk. Ajju Rahaman S/o Lt. Sk. Rakhal Vill-7 Panjaica P.S.-Nandigram Dist. Purba Medinipur and during inspection it was found that Sk. Ajju Rahaman S/o Lt. Sk. Rakhal has got one energy meter cutting meter no-11159917 & Con ID-200315008, but instead of that he was consuming electricity dishonestly by way of direct hooking from against M.T. mains for bypass the energy through meter without recording of energy unit in meter to run his domestic premises causing loss of revenue to WBSEDCL to the tune of load 1.2 KVA.

As on 17.03.2017 was detected during the inspection, at first the supervisor disconnected the unauthorized hooking cable from M.T. mains and thereafter some black color two core PVC cable with non-impervious plastic pipe and some yellow cables No.521519 in the name of Mr. Ajju was seized under a memo of seizure list in presence of witnesses and obtained their signature on the seizure list accordingly. After seizure articles were packed, sealed and then the signature of the witnesses was obtained. Mr. Dasgupta also prepared an inspection report at site with duly signed by witnesses. I approached to Mr. Dasgupta to sign the seizure and inspection report but he refused to sign on it. After completion of the inspection, the inspection team left the premises at 01:45 pm.

Thus the accused Sk. Ajju Rahaman S/o Lt. Sk. Rakhal Vill-7 Panjaica P.S.-Nandigram Dist. Purba Medinipur has committed an offence under section 135(i)(b) of the electricity act 2003 read with amendment act 2007 in view of theft of electricity through direct hooking without recording of energy for his wrongful gain.

So, Mr. Sir, requested to take cognizance of this complaint and treat it as CR.
