Dear Sir,

I do hereby lodged a complaint empowered by the electricity Act 2003 read with amendment act 2007 to the effect that Anil Bhunia S/o- Lt. Surendra Bhunia Vill.-Amdabad P.S.-Nandigram Dist- Purba Mednipur has committed theft of electricity u/s 135 of the Electricity Act 2003 read with amendment act 2007 as stated here under.

On 05.06.2017 at about 03.25 pm I, Sri Shyamsundar Mondal AE & Station Manager Nandigram CCC along with Manik Pal (SAE), Tapas Sarkar (TSH) all of Nandigram CCC with other official entered to the commercial (saw mill) premises of Anil Bhunia S/o- Lt. Surendra Bhunia Vill.-Amdabad P.S.-Nandigram Dist- Purba Mednipur and during inspection it was found that Anil Bhunia S/o- Lt. Surendra Bhunia was consuming electricity dishonestly by way of direct hooking arrangement from the nearest LT mains to run his commercial premises causing loss of revenue to WBSSEDCL to the tune of load 0.2 KVA.

As the Theft was detected during the inspection, at first the unauthorized hooking wire was disconnected and removed from L.T Mains and thereafter some portion of hooking wire black color single core each with hooking portion 3 mtr. Approximate was seized under a memo of seizure list in presence of witnesses and obtained their signature on the seizure list accordingly. Above seizure articles duly packed, labeled and then the signature of the witnesses also obtained on it. I also prepared an inspection report at site with duly signed by witnesses. I approached to accused to sign on the seizure and inspection report but he refused to sign on it. After completion the inspection, the inspection team left the premises at 03.40 pm.

Thus the accused Anil Bhunia S/o- Lt. Surendra Bhunia Vill.-Amdabad P.S.-Nandigram Dist- Purba Mednipur has committed an offence under section 135(i)(a) of the electricity act 2003 read with amendment act 2007 in view of theft of electricity through direct hooking for less recording of energy for his wrongful gain. .

So you are requested to take cognizance of this complaint and treat it as FIR.
