Sir,

In producing herewith one accused person namely Himangshu Kar (52) s/o Lt. Khirod Kar of Vill - Kalicharanpur PS- Nandigram Dist- Purba Medinipur under arrest along with following seized articles as per seizure list and relevant documents. I ASI SK. Jobed attached with Nandigram PS do hereby lodged a complaint against the above noted accused person as suomoto to the effect that today (09.06.17) at 18:05 hrs in course of my evening mobile duty received information that one person is selling I.D liquor & Country spirit in his house at Kalicharanpur under Nandigram PS. Then I informed O/C Nandigram PS and as per his kind instruction I along with C/293 Sankar Neogi, LC/1790 Pampa Das and C/ 496 Md. Mijanur Rahaman of SAP-6th Bn. all of Nandigram PS left for Kalicharanpur to work out the information. We reached at Kalicharanpur at about 18:45 hrs and found the above noted accused person was selling I.D liquor & country spirit in his house at Kalicharanpur. Then we came close to the spot and all the customers successfully fled away and we chased them and able to intercept the above noted accused person. The arrested accused person failed to produce any valid license/documents in favour of such business and possession of I.D liquor & country spirit. On interrogation he disclosed his identity as noted above and also confessed his guilt. As the said accused person of such possession of I.D liquor & country spirit having no license. He is running such type of clandestine business without obeying the provision of the Bengal Excise Act. He is committed an offence u/s 46A(C) B.E. Act. 1909. So I arrested him and seized one 10 ltrs plastic Jar cane containing approx 08 ltrs. of I.D liquor (value-800/-) and 15 bottle of CAPTAIN (country spirit) each containing 600 ml (value -15x65=975/-) from his possession after preparing arrest memo, seizure list & label duly signed by the witnesses and the accused person with one 375 ML glass bottle containing such I.D liquor collected from that Jar cane as sample and one bottle of CAPTAIN (country spirit) as sample with label.

I therefor pray that a suitable case may be initiated against the above noted accused person under proper section of law.
