Sir,

In producing herewith accused person Kalpana Mondal aged 55 yrs. W/o Shyamcharan Mondal of vill.- Krishnanagar, P.S. -Nandigram along with seized articles (1) 05 (Five) bottles of Captain Brand country spirit each bottle containing 600 ml. and Rs 65/- each (2) 06 (six) ltrs. of ID liquor (Cholai) approx. in a plastic jarikane under proper seizure list. I ASI Amitava Mukherjee do hereby lodge complaint to the effect that today i.e.19/06/2017 at 17:05 hrs. myself along with C/260 Manoranjan Adak and C/279 Kolyan Das and LCV/ Sagarika Maity left P.S for Special mobile duty vide Nandigram P.S area C.C No- 308/17, dated 19/06/17 and GDE No- 249 dated 19/06/2017. During evening mobile duty at about 17:15 hrs. we reached at village Krishnanagar under Nandigram PS and found that one person selling ID liquor (Cholai), country spirit etc. to the public from her house. We contacted with local people and request them to assist police personnel and they agreed. After that we held raid at the house of ID liquor seller person and apprehended her and being asked she disclose her identity as Kalpana Mondal aged 55 yrs. W/o Shyamcharan Mondal of vill.- Krishnanagar, P.S. -Nandigram. Search was made in presence of above noted public witnesses, police party and also apprehended person Kalpana Mondal and found (1) 05 (Five) bottles of Captain Brand country spirit each bottle containing 600 ml. and Rs 65/- each (2) 06 (six) ltrs. of ID liquor (Cholai) approx. in a plastic jarikane value about Rs. 50 per Litter. Being asked the apprehended person Kalpana Mondal fails to produce any valid documents, license, challan etc. in favour of possessing and selling of ID liquor (Cholai) etc. I seized the above noted articles after preparing proper seizure list duly signed by the witnesses as well as apprehended Kalpana Mondal. I took sample from the seized articles and labeled it. Total seized country spirit and I/D liquor (Cholai) are 06 Ltrs. approx & valued cash of Rs. 625/-approx. It is crystal clear that Kalpana Mondal illegally possessed & sell country spirit and I/D liquor (Cholai) to publics.

Under the above backdrops I pray a cog. case may kindly be started against accused person namely Kalpana Mondal W/o Shyamcharan Mondal of Krishnanagar P.S. -Nandigram, Purba Medinipur under proper section of law.
