In producing here with three arrested accd. person namely (1) Bulu Das(33) s/o Lt. Raghu of vill- Koutapally, Ward No.10, PS Saroda, Dist-Ganjam, Odisha; (2) Aowl Tarini (50) s/o Aowl Bipra@Hanuman of vill- Dhunkuni, PS Aska, Dist-Ganjam, Odisha; (3) Edalu Ganesh@Ganesh Rao (31) s/o Edalu Krishna@Krishna Rao of vill- Baro Khodal Sai, PS Saroda, Dist-Ganjam, Odisha; along with seized articles.

I SI, Debobrata Bera, of Nandigram PS do here by lodged a written complaint against the above noted accd person to the effect that today on 22.06.17 at 21.05 hrs duty officer SI Naba Kumar Koley received a secret source information that the above noted accused persons will come at Nandigram Bus Stand at around 22.00 hrs to make over forged Indian Currency notes of Rs. 100/- to their agent/ilk. Accordingly he diarized the information vide Nandigram P.S. GDE No. 1099 dt.22/06/17 at 21.05 hrs. and informed Superiors over telephone and as per their direction at 21.25 hrs myself along with ASI Jamshed Ali Shah, C/718 Shyamal Pathak; CI/1167 Satyajit Pani; CI/1161 Bijunath Singh left for Nandigram Bus Stand to work out the information vide Nandigram P.S. GDE No. 1101 dtd. 22/06/17.

At 21.35 hrs. we reached at Nandigram Bus Stand and met with my source and took safe position. At 22.15 hrs we noticed that three persons are waiting in front of Waiting room of Bus stand. As per source identification immediately we came out from ambush and encircled the person. On interrogation they disclosed their identity as noted above.

I told them that we have the information that they are carrying forged Indian Currency notes and possessing the same illegally and came here to hand over those forged currency notes to other agents through whom forged notes will be circulated as genuine in the market. I also told them that their person is required to be searched. I offered them to search ourselves as right to search and issued notice upon them and was received by them. Accordingly they searched us and all the witnesses first and found nothing except govt. arms & ammunition and personal belonging and I prepared a Nil search list which have been signed by the witnesses & by the detained persons with date.

There after maintaining all formalities, I searched the above noted persons in presence of witnesses and recovered (1) total nine (09) nos of forged Indian Currency notes as per seizure list found from the right side of his jeans pant back pocket; from the exclusive possession of Bulu Das(33) s/o Raghu of vill- Koutapally, Ward No.10, PS Saroda, Dist-Ganjam, Odisha;

and (2) total eleven (11) nos of forged Indian Currency notes as per seizure list found from the right side of his barmuda pocket from the exclusive possession of Aowl Tarini (50) s/o Aowl Bipra@Hanuman of vill- Dhunkuni, PS Aska, Dist-Ganjam, Odisha; and

(3) total ten (10) nos of forged Indian currency found from the right side of his barmuda pocket, from the exclusive possession of Edalu Ganesh@Ganesh Rao (31) s/o Edalu Krishna@Krishna Rao of vill- Baro Khodal Sai, PS Saroda, Dist-Ganjam, Odisha.

On interrogation they confessed that they used to deal with forged currency notes and they obtained the said forged Indian currency notes from one Shiva Rao of Kharagpur, Dist- Paschim Medinipur. They could not tell about the residence of said Shiva Rao or any other details. On being questioned they failed to give any satisfactory answer in support of possession of such forged notes.

As they are liable to be prosecuted U/S 489B/489C/120B IPC; I seized (i) Total nine(09) no of Indian Currency notes denomination of Rs. 100/ each said to be forged out of which

seven (07) nos of the said currency bears the same SL No:-6EQ670378 and one (01) note bear SL No. 6EQ670363 and one (01) note bear SI No. 6EQ670390 (Marked as Exhibit "A") seized from the exclusive possession of Bulu Das(33) s/o Raghu of vill- Koutapally, Ward No.10, PS Saroda, Dist-Ganjam, Odisha;

(ii) Total eleven (11) nos of Indian Currency notes denomination of Rs. 100/ each said to be forged out of which eight (08) nos of the said currency bears the same SL No:-6EQ670375 and two (02) note bear SL No. 6EQ670370; one(01) note bear SI No. 6EQ670368 (Marked as Exhibit "B") seized from the exclusive possession of Aowl Tarini (50) s/o Aowl Bipra@Hanuman of vill- Dhunkuni, PS Aska, Dist-Ganjam, Odisha;

(iii) Total ten (10) nos of Indian Currency notes denomination of Rs. 100/ each said to be forged all bears the same SL No:-6EQ670381 (Marked as Exhibit "C") seized from the exclusive possession of Edalu Ganesh@Ganesh Rao (31) s/o Edalu Krishna@Krishna Rao of vill- Baro Khodal Sai, PS Saroda, Dist-Ganjam, Odisha under proper seizure list in presence of both the witnesses and duly signed by them with date as alamat.

I took signature of the accd persons in the seizure list with date and a copy of seizure list given to seize forged notes are kept in three separate envelopes and sealed properly in presence of witnesses and accused and their signature obtained on all the three envelopes. I also took signature of the accused persons and witnesses over the seized forged notes. All the seized articles sealed and labeled properly. Thereafter I arrested them after communicating those grounds of their arrest and issued memo of arrest. I left for PS with the seized articles and arrested accd persons.

On returning to the PS I submit this written complaint to start specific case against the above noted accused persons as suo-moto, took all informative action.
