Sir,

In producing herewith one accused persons namely Panchanan Gayen (48) S/O Lt. Murari Gayen of Village Amdabad, PS Nandigram Dist - Purba Medinipur under arrest along with seized article - 20 ltrs. (Approx) I.D liquor (Cholai) in one plastic Jar can per seizure list and relevant documents. I SI Naba Kumar Koley of Nandigram PS Dist. Purba Medinipur do hereby lodged a complaint against the above noted accused person to the effect that today (24.06.17) at 18.25 hrs in course of my evening mobile duty received information that one person is selling I.D liquors at Amdabad in house cum shop of Panchanan Gayen. Then I informed O/C Nandigram PS and as per his order I along with LC/1790 Pampa Das, NVF Sk Salim Ali both of Nandigram PS and C/351 Habib Sk of SAP 6th Bn. Of attached Nandigram PS Camp left for Amdabad to work out the information. We reached at Amdabad at about 19.15 hrs and found that the above noted accused person was selling I.D liquor on at Amdabad in house cum shop of Panchanan Gayen. Then we came close to the spot and all the customers successfully fled away and we chased them and able to intercept the above noted accused person. On interrogation he disclosed his Identity as noted above. The arrested accused person failed to produce any valid license/documents in favor of such business and possession of I.D liquor. On interrogation the above noted accused person confessed his guilt. As the said accused person such possession of I/D liquor having no license. He is running such type of clandestine business without obeying the provision of the Bengal Excise Act. He is committed an offence U/S 46(A)(c) B.E. Act of 1909. So I arrested him and seized (I) One 20 liters Jar cane containing 20 liters (approx) I.D liquors (value - 2000/- approx) from his house after preparing proper seizure list with label duly signed by the witnesses and the accused person. I also taken one 375 ML glass bottle containing such I.D liquor collected from that Jar cane as sample with label.

I therefore pray that a suitable case may be initiated against the above noted accused person under proper section of law.
