Thus said Sri Sudhangshu Sekhar Sahoo misappropriated government money to the extent of Rs 600.00 against the above mentioned Recurring Deposit account and the defrauded amount in respect of Recurring Deposit account no 8246901802 is Rs 600.00.

Therefore it is alleged that the said Sri Sudhangshu Sekhar Sahoo misappropriated government money to the extent of Rs 1400+Rs 3500+ Rs 600= Rs 5500.00 against the Recurring deposit account no 8246878162 , 8246910976 & 8246901802 respectively. On considering the pros and cons of the circumstances which has thus arisen and simultaneously tarnished the image of the Department before Public , you are requested for treating the matter on top most urgent to exercise a severe investigation in the case taking cognizance of the fact thus happened and narrated above as well as it is urged upon at your own disposal to adopt a suitable lawful action against the accused as to be deemed proper.
