Sir,

In producing herewith arrested accused person namely Haripada Giri (48), S/O-Lt Nanigopal Giri, Vill- Sonachura, PS- Nandigram Dist.- Purba Medinipur along with the following seized articles as per seizure list with all relevant documents. I SI Monoranjan Mondal of Nandigram PS, Dist.- Purba Medinipur do hereby lodged a written complaint against the above noted accused person as suomoto to the effect that today (21.1.17) at 17.55 hrs in course of special mobile patrol duty received an information that one person is selling I.D liquors in his grocery shop at Sonachura Bazar under Nandigram P.S. Then I informed the matter to the O/C, Nandigram PS and as per order of O/C, Nandigram PS I along with C/1538 Sk Sajahan and C/1361 Dilip Ch. Roy both of Nandigram PS left for Sonachura Bazar to work out the information. At about 18.25 hrs we reached at Sonachura Bazar and found that the above noted person is selling I.D liquor in his grocery shop at Sonachura Bazar. Then we came close to the spot. Seeing the police party all the customers fled away successfully and also found that the above noted person tried to flee away. Then we chased against him and able to intercept the above noted person. On demand said person. failed to produce any valid license/documents in favour of such business and possession of I.D liquor. On interrogation the above noted person confessed his guilt. The said person had no license for keeping such possession of I/.D liquor. He is running such type of clandestine business without obeying the provision of the Bengal Excise Act. So he is committed an offence U/S 46A (c) of B.E. Act of 1909. So I arrested him after issuing Memo of Arrest and seized 1 (one) 10 Lts Jar cane containing 08 Litters (Approx) I.D Liquor which approximate value of Rs.800/- from his possession after preparing proper seizure list in which duly signed by the witnesses and also signed by the above noted person and labeled it and I have collected I.D. liquor in a 375 ML glass bottle from the said Jar cane as sample and label it.

The incident has already been communicated with the O/C, Excise department at Nandigram Circle, Reapara.

Hence, I therefore pray before you that a suitable case may kindly be initiated against the above noted accused person under proper section of law.
