In producing herewith one accused person namely Haripada Giri (48) S/O Lt. Nanigopal Giri of Vill. + P.O. - Sonachura, P.S. - Nandigram, Dist. - Purba Medinipur and also brought the following seized articles as -

- 1) (i) MC-Dowell's No. 1 (Rum), 06 Bottles, each 375 ml. value per bottle Rs. 180/-  
 (ii) Officer's Choice, 06 Bottles, each 375 ml. value per bottle Rs. 200/-
  - 2) Haywards-5000, 24 bottles, each 650 ml. value per bottle Rs. 100/-
  - 3) (i) MC-Dowell's No. 1 (Rum), 18 Bottles, each 500 ml. value per bottle Rs. 230/-  
 (ii) MC-Dowell's No. 1 (Rum), 48 Bottles, each 180 ml. value per bottle Rs. 90/-
- Each seizure Sl. No. 1,2 & 3 kept in white plastic packet separately in seal condition.  
 Total - 37,740 ml. & Total value Rs. 13,140/-

I SI Vivekananda Halder attached with Nandigram PS, Dist. Purba Medinipur do hereby lodged a complaint against the above noted accused person to the effect that today (28.01.17) at 18:45 hrs in course of my mobile duty received one information that one person was selling liquor in an open place at Purusattampur Sha Para near burning place under Nandigram PS. Informed OC, Nandigram PS & as per his instruction had been to the place and found the above noted accused person selling liquor. All the customers successfully fled away and we chased him and able to intercept. On being asked he failed to produce any valid license/documents in favor of such business and possession of liquor. On interrogation he confessed his guilt. I seized the above mentioned liquors from his possession under proper seizure list and labelled duly signed by the arrested person & witnesses and arrested him under B.E. Act and informed him ground of arrest.

This is to note here that the incident has already been communicated with OC, Excise Department at Reapara under Nandigram PS. Also note here that the arrested person was arrested on 21.01.17 for the same reason and this refers Nandigram PS Case No. 36/17, dated - 21.01.17 U/S - 46-A(c) B.E. Act.

I therefore pray that a suitable case may be initiated against the above noted accused person under proper section of law.
