To The Officer in Charge, Nandigram P.S., Purba Medinipur

Sir,

In producing herewith the accused persons namely Kalpana Mondal (58) W/O Shyam Charan Mondal of Krishnanagar, PS - Nandigram Dist. - Purba Medinipur under arrest along with following seized articles as per seizure list and relevant documents. I SI Sanjay Kumar Maity attached with Reapara OP under Nandigram PS Dist. Purba Medinipur do hereby lodged a complaint against the above noted accused person as suomoto to the effect that today (10.02.2017) at 17.05 hrs in course of mobile duty received information that one person is selling I.D liquors from her house at Krishnanagar, PS - Nandigram. Then I informed the officer in charge of Nandigram PS and as per his instruction I along with C/201- Shibram Saha & LCV-Moumita Giri both of Reapara OP under Nandigram PS left for Krishnanagar to work out the information. We reached at Krishnanagar at about 17.20 hrs and found the above noted accused person was selling I.D liquor from her house at Krishnanagar. Then we came close to the spot and all the customers successfully fled away and we chased them and able to interception the above noted accused person. The arrested accused person failed to produce any valid license/documents in favour of such business and possession of I.D liquor. On interrogation the above noted accused person confessed her guilt. As the said accused person such possession of I/. D liquor having no license. She is running such type of clandestine business without obeying the provision of the Bengal Excise Act. So She committed an offence U/S 46A(c) B.E. Act of 1909. So I arrested her and seized 1(one) 10 Ltrs Jar cane containing 08 Litters (Approx) 1.D Liquors (value - Rs. 800 (Approx) from her possession. After preparing seizure list with label duly signed by the witnesses and the accused person with (1) one 375 ML bottles containing such I.D liquor collected from that Jar canes as sample with label.

This is to note here that the incident has already been communicated with excise department at Nandigram Circle.

I therefore pray that a suitable case may be initiated against the above noted accused person under proper section of law.
