In producing herewith one accused person namely Smt. Sefali Midya (55) w/o Rabin Midya of Ratanpur PS- Nandigram Dist- Purba Medinipur under arrest along with following seized articles as per seizure list and relevant documents. I ASI Ashis Kumar Das attached with Nandigram PS do hereby lodged a complaint against the above noted accused person as suomoto to the effect that today (13.02.17) at 15:35 hrs. in course of my evening mobile duty received information that one person is selling I.D liquor at her tea shop at Ratanpur Bus Stand under Nandigram PS. Then I informed O/C Nandigram PS and as per instruction along with LC/1810 Rina Mal, C/1167 Satyajit Pani and V.P. Amit Kr. Das all of Nandigram PS left for Ratanpur Bus Stand to work out the information. We reached at Ratanpur Bus Stand at the Tea shop of above noted accd, at about 15:55 hrs. and found the above noted accd, person was selling I.D liquor at her tea shop. Then we came close to the spot and all the customers successfully fled away and we chased her and able to intercept the above noted accd. person. The arrested accd, person failed to produce any valid license/documents in favour of such business and possession of I,D liquor. On interrogation the above noted accd. person confessed her guilt. As the said accd, person of such possession of I.D liquor having no license. She is running such type of clandestine business without obeying the provision of the Bengal Excise Act. She is committed an offence u/s 46A(C) B.E. Act. 1909. So I seized one 05 ltrs. plastic Jaricane containing approx. 03 ltrs. of I.D liquor (value-300/-) from her possession and arrested her after prepairing arrest memo, seizure list & label duly signed by the witnesses and the accd, person with one 375 ML bottle of glass containing such I.D liquor collected from that Jaricane as sample with label.

I therefor pray that a suitable case may be initiated against the above noted accused person under proper section of law.
