In producing herewith 03 (Three) accused persons namely (i) Chandan Mondal (30yrs) S/O Swapan Mondal of Subdi (ii) Biswajit @Rabi Mondal (31) S/O Pashupati Mondal of Chandannagar (iii) SK, Year Ali @ Bhuttu (40) S/O Lt SK Nowshed, of Naynan all of PS- Nandigram , Dist- Purba Medinipur along with following seized 13 liters I/D liquor in two plastic jar cane and sezure list.

I. ASI Ashok Kumar Dal of Nandigram PS do hereby lodge a written complaint against the above noted accused persons to the effect that today (23.02.17) at 19:15 hrs in course of evening mobile duty received a telephonic information that one Chandan Mondal along with two others were running their clandestine business by selling 1/D liquor at his house unauthorizedly and accordingly I informed to O/C Nandigram PS and as per his kind instruction myself along with C/ 1615 Rashbihari Barik HG Jakir Hossain Khan had been to Subdi vide C.C No.539/17 dated 23.02.17 and identified the house of Chandan Mondal at 20.05 hrs found that he along with two others were selling I/D liquors seeing police party Some persons who were seating & comsuming I/D liquor started the flee away. But we managed to apprehend the above noted three accused persons. Accordingly we searched and 13 liters (Approx) of I/D liquor contained in one plastic jaricane kept in his house. On asked they failed to produce any license/receipt/any others valid document in support of above quantities of liquors which they were selling unauthorizedly in the house of Chandan Mondal . So, I arrested them after observing all formalities and seized the above quantities of liquor in presence of witnesses after prepared proper Seizure list & label duly signed by them and the accused persons and 375 ml JD liquor taken as sample in a bottle. I like to note that when the accused namely Biswajit @Rabi Mondal (31) S/O Pashupati Mondal of Chandannagar PS Nandigram Dist Purba Medinipur was trying to flee away, then he felldown on earth & received injury & he was medically treated also .

Under the above fact and circumstances, I pray before you that a specific case may kindly be started against (i) Chandan Mondal (30yrs) S/O Swapan Mondal of Subdi , (ii) Biswajit @Rabi Mondal (31) S/O Pashupati Mondal of Chandannagar (iii) SK, Year Ali @ Bhuttu (40) S/O Lt SK Nowshed, of Naynan all of PS- Nandigram , Dist- Purba Medinipur, along with above noted seized articles under proper section of law and arrange for its investigation.
