Dear Sir,

I do hereby lodged a complaint empowered by the electricity Act 2003 read with amendment act 2007 to the effect that Saiyad Mukhlesur Ali S/o-Lt.Saiyad Mannan Ali Vill.-Champainagar P.S-Nandigram Dist- Purba Mednipur has committed theft of electricity u/s 135 of the Electricity Act 2003 read with amendment act 2007 as stated here under.

On 03.03.2017 at about 12.15 pm I, Sri Shyamsundar Mondal AE(E) & SM,Nandigram CCC along with Manik Pal (SAE), Uttam Kr Maity (LM),Tapas Sarkar (TSH) all of Nandigram CCC with other official entered to the domestic premises of Saiyad Mukhlesur Ali S/o-Lt.Saiyad Mannan Ali Vill.-Champainagar P.S.-Nandigram Dist- Purba Mednipur and during inspection it was found that Saiyad Mukhlesur Ali S/o-Lt.Saiyad Mannan Ali Vill.-Champainagar has got one energy meter bearing meter no.P1758757 and con.ID.200385555 instead of that he was consuming electricity dishonestly through direct hooking using separate wire from nearest LT mains for less recording of energy unit in meter to run his domestic premises to the tune load of 0.8 KVA causing loss of revenue to WBSEDCL.

As the Theft was detected during the inspection, the service connection was disconnected and removed from L.T Mains and thereafter some portion of hooking wire red and blue color 3 mtr. approximate was seized under a memo of seizure list in presence of witnesses and obtained their signature on the seizure list accordingly. Above seizure articles duly packed, labeled and then the signature of the witnesses also obtained on it. I also prepared an inspection report at site with duly signed by witnesses. After completion, the inspection team left the premises at 12.35 pm.

Thus the accused Saiyad Mukhlesur Ali S/o-Lt.Saiyad Mannan Ali Vill.-Champainagar P.S.-Nandigram Dist- Purba Mednipur has committed an offence under section 135(i)(b) of the electricity act 2003 read with amendment act 2007 in view of theft of electricity through direct hooking for less recording of energy for his wrongful gain. .

So you are requested to take cognizance of this complaint and treat it as FIR.
