Dear Sir,

I do hereby lodged a complaint empowered by the electricity Act 2003 read with amendment act 2007 to the effect that Sk Samad S/O Lt.Sk.Abdul Sukur Vill-Champainagar(adjacent to Priyanagar) P.S-Nandigram Dist- Purba Medinipur has committed theft of electricity u/s 135 of the Electricity Act 2003 read with amendment act 2007 as stated here under.

On 03.03.2017 at about 01-15 pm I Sri Dibyendu Sekhar Bhunia D.E(S&LP) Purba Midnapur Regional office along with Shyamsundar Mondal AE(E) & SM ,Manik Pal (SAE),Uttam Kumar Maiti L.M all of Nandigram CCC with other official entered to the domestic premises of Sk.Samad S/O Lt.Sk.Abdul Sukur Vill.-Champainagar(adjacent to Priyanagar) P.S.-Nandigram Dist- Purba Medinipur and during inspection it was found that Sk. Samad was consuming electricity dishonestly by way of direct hooking from nearest LT mains to run his domestic premises for his wrongful gain causing loss of revenue to WBSEDCL to the tune of load 0.71 KVA.

As the Theft was detected during the inspection,at first we removed the unauthorised hooking wire from LT Mains and thereafter some portion hooking wire black color with hooking portion 3mtr. Approximate was seized under a memo of seizure list in presence of witnesses and obtained their signature on the seizure list accordingly.I approached to accused person Sk.Samad to give witness to the seizure list and inspection report but denied to sign on it. Above seizure articles duly packed, labeled and then the signature of the witnesses also obtained on it. I also prepared an inspection report at site with duly signed by witnesses. After completion, the inspection team left the premises at 01-35 pm.

Thus the accused Sk. Samad S/o- Lt. Sk.Abdul Sukur Vill.-Champainagar(adjacent to Priyanagar) P.S.-Nandigram Dist- Purba Medinipur has committed an offence under section 135(i)(a) of the electricity act 2003 read with amendment act 2007 in view of theft of electricity through direct hooking for his wrongful gain. .

So you are requested to take cognizance of this complaint and treat it as FIR.
