Sir,

In producing herewith one arrested accused person namely Basudeb Das (34yrs) S/O Subhash Das of Ranichak, PS- Nandigram, Dist- Purba Medinipur along with following seized articles under proper seizure list 08 liters of I/D liquor contained in one plastic jar cane.

I, ASI Ashok Kumar Dal of Nandigram PS. do hereby lodge a written complaint against the above noted accused person to the effect that on 16.03.17 at 23.15 hrs in course of night mobile duty received a telephonic information that one Basudeb Das of Ranichak PS Nandigram was running his clandestine business by selling I/D liquor at his house unauthorized and accordingly I informed to O/C Nandigram PS and as per his kind instruction myself along with C/ 1559 Uttam Ghosh & C/1572 Hemal Murmu vide C.C No.737/17 dated 16.03.17 reached at village Ranichak at 00:05 hrs and identified the house of above noted accused person, found that he was selling I/D liquors along with other fresh liquor. Accordingly we searched and 08 liters (Approx) of I/D liquor contained in one plastic jaricane kept in his house. On asked he failed to produce any license/receipt/any other valid document in support of above quantities of liquors which he was selling unauthorizedly in his house. So, I arrested him after observing all formalities and seized the above quantities of liquor in presence of witnesses after prepared proper Seizure list & label duly signed by them and the accused person and 375 ml ID liquor taken as sample in a bottle.

Under the above fact and circumstances, I pray before you that a specific case may kindly be started against Basudeb Das (34yrs) S/O Subhash Das of Ranichak, PS- Nandigram, Dist- Purba Medinipur along with above noted seized articles under proper section of law and arrange for its investigation.
