Sir,

In producing herewith the one accused person namely (1).Panchanan Gayen (48) S/o- Lt - Murari Gayen of Amdabad PS Nandigram, Dist. - Purba Medinipur he was arrested from Amdabad village under Nandigram PS and also brought the following seized articles as -1) Thirty Five (35) Its of ID liquar in a plastic jarican, cost of Rs. 100/- per liter and total value about Rs. - 3500/-

I ASI Aniruddha Chakborty of Reapara OP under Nandigram PS Dist. Purba Medinipur do hereby lodged a complaint against the above noted accused person to the effect that today (30.03.17) at 17.25 hrs in course of my special Mobile duty at Amdabad village, under Nandigram PS & getting information one person selling liquor from his house at Amdabad village. On getting such information my self along with C/260 Manoranjan Adak and C/279 Kalyan Das both of Reapara OP under Nandigram Ps held raid at Amdabad village and the accused person tried to fled away but we mannaged to got him. On asked he disclosed his identity as noted above and on demand he failed to produce any valid documents /license etc of the said liquor. On interrogation he confessed his guilt. I informed the matter to OC, Nandigram PS and as per his order I seized the above mentioned liquors conting in a plastic jarican conting in plastic jarican conting in plastic jarican conting in plastic jarican proper segure list from his possession and arrested him under B.E. Act and informed him ground of arrest I also took sample in one bottle of 375 ml from seized Id liquer.

This is to note here that the incident has already been communicated with OC, Excise Department at Reapara under Nandigram PS.

I therefore pray that a suitable case may be initiated against the above noted accused person under proper section of law.
