Kalichak P.O.-Itanogra, Dist- Purba Medinipur for committing theft of electricity
in his house by tampering the incoming cable to bypass the meter registration.**

Sir,

I, Sri Santu Datta, S/O Sri Sambhunath Datta, AE & SM of Nandakumar CCC, WBSEDCL, PO+PS- Nandakumar do hereby lodge a complaint against Laxmikanta Manna, S/O Lt Srikanta Manna of village-Kalichack, P.O.- Itanogra, P.S.- Nandakumar for committing theft of electricity by tampering the incoming cable to bypass the meter registration of WBSEDCL.

To the effect that today i.e. 28.03.2017 at about 12:20 hrs myself, along with Sri Chandan Hudait, Sr. SAE(E), Sri Tapan Adak, LM, Sri Rabindranath Adak, Sr. TSH and others of Nandakumar CCC, WBSEDCL left for Kalichack Village for inspection by official hired vehicle.

We reached Kalichack Village at about 12:55 hrs and came to the house of Laxmikanta Manna at about 13:00 hrs and found that he was committing theft of electricity in his pucca house by tampering the incoming service cable at his kitchen before entering into the meter to by passing the proper registration of energy unit. He was a consumer of WBSEDCL vide consumer ID: 222240083. We disconnected his service Line and seized the following materials in presence of witnesses i) Sri Chandan Hudait & (ii) Sri Tapan Adak duly signed by them on the seizer list. Accused Laxmikanta Manna was present & put his signature on inspection sheet & seizure list. Local people were present but none appeared. **Seized Material** (i) 2 core 6 Sqmm 05 Mtr (approx) black PVC cable in tampered condition & (ii) 02 mtr (approx) 2.5 sqmm PVC cable with a female plug. The seizer was made in between 13:10hrs to 13:20 hrs. We inspected the premises and the load found during inspection was 620 watt. We left the premises at about 13:25 hrs on 28/03/2017.

The WBSEDCL has incurred huge loss for the illegal activity of Sri Laxmikanta Manna. Sri Laxmikanta Manna has committed theft of electricity and liable for prosecution u/s 135/1(b) of Electricity Act 2003 as amended in 2007.

Therefore, you are requested to take necessary action against Sri Laxmikanta Manna S/O Lt Srikanta Manna of Kalichack village, P.O.- Itanogra, P.S.- Nandakumar Dist- Purba Mdinipur.
