Sir,

In producing here with arrested accused namely Kalpana Das (65) W/O-Lt Sankar Das of vill-Puyada P.S-Nandakumar Dist-Purba Medinipur along with Proper seizure list and 15 liters of I/D liquor(Cholai) contained in one plastic jar cane and 07 bottle country Spirit in a Tray.

I SI Bhabani Prosad Mukhopaddhay of Nandakumar PS. do hereby lodge a written complaint against the above noted accused person to the effect that today on 17.04.17 at 16:05 hrs myself along with Const. 190 Kisan Kisku and L/C-1820 Sahajadi Khatoon were performing mobile duty vide Nandakumar P.S. C.C No-591 Dt-17.04.17 received a source information that one person is selling I/D liquor (Cholai) in her shop at Puyada under Nandakumar PS. After receiving such information I informed to O/C Nandakumar P.S and as per his instruction Myself along with force reached at Puyada under Nandakumar PS at 16:35 hrs. and found that one person was selling I/D liquor(Cholai) from her shop situated at Puyada under Nandakumar PS to the peoples and passersby and found that 15 ltr of I/D Liquor(Cholai)approx in one plastic jaricane(2) 07 Bottle Country Spirit is lying at her shop. But on getting scent the arrival of police said I/D liquor(Cholai) sellers tried to fled away . But we (police party) could manage to apprehend him. On being interrogation She disclosed her identity as mentioned above and confessed that She was selling I/D liquor (Cholai) at that Place illegally. On demand She failed to produce any valid license/documents/ challan etc in supports of such possession and selling of I/D liquor (Cholai) . Accordingly I arrested her with the help of L/C-1820-Sahajadi Khatoon .During arreste issued memo of arrest and informed her the ground of arrest and informed her relative and seized 15(fifteen) liters of I/D liquor (Cholai) in one Plastic Jaricane total amounting Rs 850/- (approx)(2) 07 bottle Country Spirit after prepared proper seizure list in presence of witnesses from their possession duly signed by the witnesses and arrested person and also took 375 ML I/D liquor as Sample also took 01 bottle Country Spirit from seized articles and labeled also. It is evident and crystal clear that the arrested accused was selling I/D liquor (Cholai) violating provision of section 46 A (C) of Bengal Excise act. 1909.

Under the above fact and circumstances I pray before you that a specific case may kindly be started against Kalpana Das(65) S/O-Lt Sankar Das of vill Puyada P.S-Nandakumar Dist-Purba Medinipur along with above noted seized articles under proper section of law and arrange for its investigation.


