In producing here with arrested accused namely Santosh Bera (age 40 yrs) S/O- Radhakanta of Chak Puyada, PS- Nandakumar Dist- Purba Medinipur along with proper seizure list and 05 bottles country spirit.

I, I ASI Narugopal Dev of Nandakumar PS do hereby lodge a written complaint against the above noted accused person to the effect that today 19/04/17 at 21.05 hrs in course of evening mobile duty received a telephonic information that one person namely Santosh Bera (age 40 yrs) S/O- Radhakanta of Chak Puyada, PS- Nandakumar Dist- Purba Medinipur is running his clandestine business by selling liquor at his shop unauthorized at Babyatterhat and accordingly I informed to O/C Nandakumar PS and as per his instruction myself along with const./527 Raghunath Mondal, Const/1541 Amit Das & LC/ 1823 Shampa Kundu had been to Byabatterhat at 21.25 hrs vide Nandakumar PS C.C No.- 901 dated 19.04.17 and identified the shop of above accused person and found that he was selling liquor. Accordingly we searched and found 05 bottles country spirit kept in his shop. On being asked he failed to produce any license/receipt/any other valid document in support of above quantities of liquors which he was selling unauthorizedly in his shop. So, I arrested him after observing all formalities and seized the above quantities of liquor in presence of witnesses after preparing proper Seizure list duly signed by them and the accused person and 01 bottle country spirit has been taken as sample.

Under the above fact and circumstances I pray before you that a specific case may kindly be started against accused namely Santosh Bera (age 40 yrs) S/O- Radhakanta of Chak Puyada, PS- Nandakumar Dist- Purba Medinipur along with above noted seized articles under proper section of law and arrange for its investigation.
