In producing here with arrested accused namely Santu Ghosh (35) S/O-Anil Ghosh of vill-Khanchi P.S-Nandakumar Dist-Purba Medinipur along with Proper seizure list and 10 liters of I/D liquor (Cholai) contained in one plastic jar cane.

I ASI Narugopal Deb of Nandakumar PS. do hereby lodge a written complaint against the above noted accused person to the effect that today on 29.04.17 at 12:25 hrs myself along with Const. 527 Roghunath Mondal Const-1038 Goutam Das and NVF-Dulal Mondal were performing mobile duty vide Nandakumar P.S. C.C No-983 Dt-29.04.17 received a source information that one person is selling I/D liquor (Cholai) & Country Spirit in his shop at Nandakumar Bazar under Nandakumar PS. After receiving such information I informed to O/C Nandakumar P.S and as per his instruction Myself along with force reached at Nandakumar Bazar under Nandakumar PS at 12:50 hrs. and found that one person was selling I/D liquor (Cholai) and Country Spirit from his shop situated at Nandakumar bazaar under Nandakumar PS to the peoples and passersby and found that 10 ltr of I/D Liquor(Cholai)approx in one plastic jaricane and 07 bottle Country Spirit is lying at his shop. But on getting scent the arrival of police said I/D liquor(Cholai) sellers tried to fled away . But we (police party) could manage to apprehend him. On being interrogation he disclosed his identity as mentioned above and confessed that he was selling I/D liquor (Cholai) and Country Spirit at that Place illegally. On demand he failed to produce any valid license/documents/ challan etc in supports of such possession and selling of I/D liquor (Cholai) and country Spirit . Accordingly I arrested him after observing all formalities. During arreste issued memo of arrest and informed him the ground of arrest and informed her relative and seized 10 liters of I/D liquor (Cholai) in one Plastic Jaricane total amounting Rs 850/- (approx) and 07 bottle country Spirit after prepared proper seizure list in presence of witnesses from their possession duly signed by the witnesses and arrested person and also took 375 ML I/D liquor and 01 bottle country Spirit as Sample also from seized articles and labeled also.
