Sir,

I, ASI Tapas Patra of Nandakumar PS do here by submit a written complaint against Srikanta Ghorai S/O- Lt. Hemanta of Vill.- Puyada PS.- Nandakumar Dist.- Purba Medinipur, the owner of Maa Tara Builders of Puyada Bazar to the effect that today on 07/05/17 I have entrusted for Morning Mobile duty vide Nandakumar PS GDE No.- 244 dated. 07.05.17, C.C No. 1049/17 Dt. 07.05.17 along with C/1038- Goutam Das, NVF Dulal Mandal and LC 1820 Sahajadi Khatun at Nandakumar PS area. During mobile duty I had been to Puyada Bazer at around 11:30 hrs and found that a huge quantity of Stone Chips has been piled on roadside in front of Maa Tara Builders blocking the footpath as well as a portion of the Nandakumar-Tamluk Road which creates immense problem for pedestrians and normal traffic. It may cause road traffic accident at any time and loss of life for pedestrians and passengers. On local enquiry, it came to know that those stone chips was piled by one Srikanta Ghorai S/O- Lt. Hemanta of Vill.- Puyada PS.- Nandakumar Dist.- Purba Medinipur, owner of Maa Tara Builders of Puyada Bazar. I searched him at that place but he could not be traced out as the shop was closed. Then I seized the following articles preparing proper seizure list and label duly signed by the witnesses.

Articles Seized:

Around 200 cft. stone chips (About 8.5 Tons).

After removing the same from roadside with the help of local people, I left the seized articles in Zimma to Shri Surja Kumar Das S/O- Lt. Beharilal Das of Vill- Puyada PS- Nandakumar Dist- Purba Medinipur, Secretary, Puyada Bazar Committee at present Vill- Tikarampur, PS- Nandakumar Dist- Purba Medinipur on condition that he will produce the same before the Ld. Court as and when call for.

Zimma Articles:

Around 200 cft. stone chips (About 8.5 Tons).

Under the above fact and circumstances, I pray before your kind self that a specific case may kindly be initiated against Srikanta Ghorai S/O- Lt. Hemanta of Vill.- Puyada PS.- Nandakumar Dist.- Purba Medinipur, the owner of Maa Tara Builders of Puyada Bazar under proper section of law for piling Stone Chips obstructing footpath and road.
