I SI Partha Pratim Maiti of Nandakumar PS, Purba Medinipur do hereby submit a written complaint to the effect that on 12.5.17 at 00.35hrs SI Vivekananda Halder, Duty Officer of Nandakumar PS received an information over telephone that some members and villagers of Narayanpur Paschim Pally, PS Nandakumar was continuing a cultural programme using loud speaker in a high volume without any permission from concerned authority causing annoyance and disturbance of local people. SI Vivekananda Halder, Duty Officer of Nandakumar PS noted the fact in GD vide Nandakumar PS GDE no dt- 12.5.17 and informed OC, Nandakumar PS. I SI Partha Pratim Maiti accompanied with ASI Bablu Dalai, ASI Tapas Patra, ASI Aminul Islam C/ 781 Anshuman Sahana, C/ 1295 Kazi Saidul Islam, C/ 1038 Goutam Das, C/ 1231 Shyampada Purkait, C/402 Sukumar Maity, LC 1787 Uma Giri, LC 1823 Sampa Kundu rushed to the spot as per order of OC, Nandakumar PS to comply the information.

On 12.5.17 at around 01.15 hrs we had been to village Narayanpur Paschim Pally and found some members of Narayanpur Paschim Pally Young Star Club under leadership of Surajit Majhi s/o Mangal, President, Uttam Bera s/o Gurupada, Secretary, Kartick Bera s/o Lt. Gour, Chandan Bera s/o Tarapada, Dipak Bera s/o Jharupada, Goutam Bera s/o Gurupada, members of Narayanpur Paschim Pally Young Star Club all of vill- Narayanpur Paschim Pally, PS Nandakumar, Dist- Purba Medinipur one Laxmikanta Maity, Mike operator of Suktara Sound were continuing a cultural programme using loud speaker in a high volume. We requested the committee to stop the loud speaker as it was dead hours of night but they did not pay any heed to our words and also failed to produce any valid permission from concerned authority for using loud speaker in a high volume. Then I stopped the loud speaker and disbursed the spectators cum mob and seized the following apparatus using for loud speaker preparing proper seizure list and label duly signed by the witnesses. At that moment the members shut down the electricity/ Generator and fled away.

- 1) 01 DVD player (Philips)
- 2) 02 Amplifiers
- 3) 01 sound mixing machine

Returning to PS, I am submitting this complaint against Surajit Majhi s/o Mangal, President, Uttam Bera s/o Gurupada, Secretary, Kartick Bera s/o Lt. Gour, Chandan Bera s/o Tarapada, Dipak Bera s/o Jharupada, Goutam Bera s/o Gurupada, members of Narayanpur Paschim Pally Young Star Club all of vill- Narayanpur Paschim Pally, PS Nandakumar, Dist- Purba Medinipur, Laxmikanta Maity, Mike operator of Suktara Sound and other unknown members of Narayanpur Paschim Pally Young Star Club for continuing cultural programme using loud speaker in a high volume without any permission from concern authority with a prayer to register a case under proper section of law.
