theft of electricity in his house by direct hooking from LT OH line of WBSEDCL.**

Sir,

I, Sri Santu Datta, S/O Sri Sambhunath Datta, AE & SM of Nandakumar CCC, WBSEDCL, PO+PS- Nandakumar do hereby lodge a complaint against Rabindranath Jana, S/O Lt Sadananda Jana of village- Saoraberia Jalpai, P.O.- Motilalchack, P.S.- Nandakumar for committing theft of electricity by means of hooking from LT line of WBSEDCL.

To the effect that today i.e. 13.05.2017 at about 12:45 hrs myself, along with Sri Chandan Hudait, Sr. SAE(E), Sri Tapan Adak, LM and others of Nandakumar CCC, WBSEDCL left for Saoraberia Jalpai Village for inspection.

We reached Saoraberia Jalpai Village at about 13:25 hrs and came to the house of Rabindranath Jana at about 13:30 hrs and found that he was committing theft of electricity in his pucca house by means of direct hooking to bypass the proper registration of energy unit. There was a connection of WBSEDCL vide consumer ID: 222236480 in the name of Ram Chandra Das, the father-in-law of Rabindranath Jana. The accused was consuming the electricity unauthorizedly. We disconnected the service Line and seized the following materials in presence of witnesses i) Sri Chandan Hudait & (ii) Sri Tapan Adak duly signed by them on the seizer list. Accused Rabindranath Jana was present & put his signature on inspection sheet & seizure list. Local people were present but none appeared. **Seized Material** one 2 core 4 Sqmm 20 Mtr (approx) black PVC cable with hooking device. The seizer was made in between 13:45hrs to 14:00 hrs. We inspected the premises and the load found during inspection was 500 watt. We left the premises at about 14:05 hrs on 13/05/2017.

The WBSEDCL has incurred huge loss for the illegal activity of Sri Rabindranath Jana. Sri Rabindranath Jana has committed theft of electricity and liable for prosecution u/s 135/1(a) of Electricity Act 2003 as amended in 2007.

Therefore, you are requested to take necessary action against Sri Rabindranath Jana S/O Lt Sadananda Jana of Saoraberia Jalpai village, P.O.- Motilalchack, P.S.- Nandakumar Dist- Purba Mdinipur.
