Sub: Prayer for lodging an F.I.R.

Sir,

In producing herewith two arrested accused persons namely i) Amar Manna (35 yrs) ii) Bhramar Manna (31 yrs) both S/O Narayan Chandra Manna of Vill. Ektarpur, PS Mahishadal, Dist. Purba Medinipur along with seized Motor Cycle bearing Registration No. WB30D/4096 (TVS Victor GLX), I ASI Narugopal Deb of Nandakumar PS do hereby lodge this complaint to the effect that today on 21.05.17 at about 18.45 hrs while I along with C/799 Kartick Mukherjee, NVF 16140176 Sankar Hazra, LC 1820 Sahajadi Khatun all of Nandakumar PS vide Nandakumar PS C.C No- 1164/17 Dt. 21.05.17 and ASI (AB) Uttam Murmu, C/1290 Taras Hansda of Nandakumar PS Traffic Wing and CV 178 Sumit Sahoo Das, CV 177 Debashis Sahoo, CV 120 Prasenjit Mahapatra all of Nandakumar PS, ASI Dilip Pramanik of Mahishadal PS Traffic Wing were performing special Drive duty at Sridharpur Morh under PS Nandakumar against Motor-Vehicle Act Violation in compliance with ORG No. 484/TR Dt. 17/05/17 under leadership of Shri Swapan Ghosh, Dy SP Traffic, Purba Medinipur, we noticed that two persons were coming towards Sridharpur Morh from Norghat side by a Motor Cycle bearing Registration No. WB30D/4096 (TVS Victor GLX). We stopped them for checking and found that the pillion rider had no helmet in his head. On being asked it came to know that the rider was i) Amar Manna (35 yrs) S/O Narayan Chandra Manna of Vill. Ektarpur, PS Mahishadal, Dist. Purba Medinipur who was with helmet but the pillion rider namely Bhramar Manna (31 yrs) S/O Narayan Chandra Manna of Vill. Ektarpur, PS Mahishadal, Dist. Purba Medinipur was without helmet. Accordingly the rider of Motor Cycle bearing Registration No. WB30D/4096 (TVS Victor GLX) namely Amar Manna was issued with a seizure list for violation of MV Act by not wearing helmet by the pillion rider U/S 177 M.V Act by ASI (AB) Uttam Murmu. At that moment both of them started hue and cry at the top of their voice and created a scene unnecessarily claiming that not-wearing of helmet by pillion rider was not an offence. While ASI (AB) Uttam Murmu tried to convince them, both of them became furious and started assaulting the Police personnel on duty by fist & blows. As a result I along with ASI (AB) Uttam Murmu, CV 177 Debashis Sahoo, CV 120 Prasenjit Mahapatra sustained injuries on their persons. Both of them were instigating the local people to join them to assault and dishonor Police. Thus they deterred public servant to discharge their lawful Govt. duty by causing assault and dishonor the on duty Police. On getting information, reinforcement from Nandakumar PS under leadership of Shri Tirtha Bhattacharjee, CI Nandakumar accompanied by SI Amiya Kumar Ghosh, O/C Nandakumar PS and available officers and force reached at the spot and pacify the situation. I arrested both i) Amar Manna (35 yrs) ii) Bhramar Manna (31 yrs) both S/O Narayan Chandra Manna of Vill. Ektarpur, PS Mahishadal, Dist. Purba Medinipur at 19.35 hrs on 21.05.17 maintaining all norms and seized Motor Cycle bearing Registration No. WB30D/4096 (TVS Victor GLX) preparing proper seizure list from their possession. All injured Police Personnels were medically treated.

Under the above fact and circumstances, I pray before your kind honour that a specific case may kindly be initiated against i) Amar Manna (35 yrs) ii) Bhramar Manna (31 yrs) both S/O Narayan Chandra Manna of Vill. Ektarpur, PS Mahishadal, Dist. Purba Medinipur as per law.
