Sir,

In producing herewith one arrested accused person namely Gouranga Ghorai (26) S/O- Manoranjan of vill- Bargoda, PS- Nandakumar, Dist- Purba Medinipur along with following seized articles under proper seizure list - i) 10 litres of I/D liquor contained in one plastic jaricane ii) 05 bottles Country spirit.

I, SI Partha Pratim Maiti of Nandakumar PS do hereby lodge a written complaint against the above noted accused person to the effect that today 22.05.17 at 16.15 hrs in course of evening mobile duty received a telephonic information that one person namely Gouranga Ghorai (26) S/O- Manoranjan of vill- Bargoda, PS- Nandakumar, Dist- Purba Medinipur is running his clandestine business by selling I/D liquor at his shop unauthorized at Bargoda accordingly I informed to O/C Nandakumar PS and as per his instruction myself along with C/1541 Amit Das C/1560 Nema Mahapatra, LC/1856 Jyotsna Gal Barman had been to Bargoda at 16.45 hrs vide C.C No.-1172 dated 22.05.17 and identified the shop of above accused person and found that he was selling I/D liquor. Accordingly we searched and found 10 liters (Approx) of I/D liquor contained in one plastic jaricane and 05 bottles country spirit kept in his shop. On being asked he failed to produce any license/receipt/any other valid document in support of above quantities of liquors which he was selling unauthorizedly in his shop. So, I arrested him at 17.05 hrs after observing all formalities and seized the above quantities of liquor in presence of witnesses in between 17.15 hrs to 17.35 hrs after preparing proper Seizure list duly signed by them and the accused person and 375 ml liquor in a bottle and 01 bottle C.S has been taken as sample.

Under the above fact and circumstances I pray before you that a specific case may kindly be started against the accd. namely Gouranga Ghorai (26) S/O- Manoranjan of vill- Bargoda, PS- Nandakumar, Dist- Purba Medinipur along with above noted seized articles under proper section of law and arrange for its investigation.


