Sir,

In producing herewith one arrested accused person namely Mongal Bhowmik (38) S/O Lt. Motilal of Dihigumai, PS Nandakumar,, Dist. Purba Medinipur along with 05 (Five) pieces Country Spirit each 600ml. and 05 (Five) Ltrs. I/D Liquors, I ASI Tapas Patra of Nandakumar PS do hereby submitted a written complaint to the effect that today on 28.05.17 at 14.05 hrs I along with C/338 tapan Kr. Maity and NVF Dulal Mondal left for PS area for performing mobile duty. During mobile duty at 19.45 hrs found that the above noted accused person is selling liquors to the different customers at Dihigumai under Nandakumar PS from his shop. On seeing police he tried to run away but we managed to apprehend the above mentioned accused person who was selling liquors to different customers. On asking, he disclosed his name as above. On search the below noted liquors were found in his shop. On enquiry, it was known that he was conducting the business of selling of liquors without any license since last few days. On demand he failed to produce any license for possessing / selling of the liquors and any paper regarding possession of such quantity of liquors. So, I arrested the above noted accused person at 20:05 hrs. and seized below noted quantity of liquors from his possession under proper seizure list duly signed by the witnesses.

Description of the seized items:

- 1) 05 (Five) pieces Country Spirit each 600ml.
- 2) and 05 (Five) Ltrs. I/D Liquors.

I also took one bottles Country Spirit and one ltr. I/D Liquor from the above-mentioned category as sample.

Since offence has been committed U/S 46A(c) of Bengal Excise Act-1909. So I pray that a specific case may kindly be started against the arrested accused person namely Mongal Bhowmik (38) S/O Lt. Motilal of Dihigumai, PS Nandakumar,, Dist. Purba Medinipur U/S 46A(c) of Bengal Excise Act-1909.
