In producing herewith one arrested accused person namely Badal Samanta (48 yrs) S/O- Lt Baneswar Samanta of Vill- Madhabpur PS- Nandakumar Dist- Purba Medinipur along with following seized articles under proper seizure list—i) 15 litres of I/D liquor contained in one plastic jaricane ii) 375 ml I/D liquor as sample in a bottle iii) 05 bottles country Spirit of which one bottle is seized as sample.

I, SI Narugopal Biswas of Nandakumar PS do hereby lodge a written complaint against the above noted accused person to the effect that today 30/05/17 at 18.25 hrs in course of evening mobile duty received a telephonic information that one person namely Badal Samanta (48 yrs) S/O- Lt Baneswar Samanta of Vill- Madhabpur PS- Nandakumar Dist- Purba Medinipur is running his clandestine business by selling I/D liquor at his shop unauthorized at Madhabpur and accordingly I informed to O/C Nandakumar PS and as per his instruction I along with C/527- Raghunath Mandal, NVF Subrata Pramanik and L/C 1820- Sahajadi Khatun had been to the village Madhabpur at 18.45 hrs vide C.C No.- 1242/17 dated- 30.05.17 and identified the shop of above noted accused person and found that he was selling I/D liquor at his shop without any valid documents. Accordingly we searched and found 15 litres (Approx) of I/D liquor contained in one plastic jaricane and 05 bottles of Country Spirit kept in his shop. On being asked he failed to produce any license/receipt/any other valid document in support of above quantities of liquors which he was selling unauthorized in his shop. So, I arrested him after observing all formalities of arrest and seized the above quantities of liquor in presence of witnesses after preparing proper Seizure list duly signed by the witnesses and the accused person and 375 ml liquor I/D liquor in a bottle and 01 bottle of Country Spirit have been taken as sample.

Under the above fact and circumstances, I pray before you that a specific case may kindly be started against the above noted arrested accused person namely Badal Samanta (48 yrs) S/O- Lt Baneswar Samanta of Vill- Madhabpur PS- Nandakumar Dist- Purba Medinipur along with above noted seized articles under proper section of law and arrange for its investigation.
