Sir,

Myself I ASI Bablu Dalai along with C/1231 Shyampada Purkait, and NVF Dulal Mondal of Nandakumar PS in producing herewith accused Sankar Dolai (47) S/O Lt. Sudhir Ch. Dolai of Thekuachak, PS- Nandakumar, Dist.- Purba Medinipur along with the below noted seized items as per seizure list. I am to state that today on 09.06.17 at about 20:45 hrs in course of evening patrolling, received a secret source information that one person is selling alcoholic liquors at Thekuachak Bazar from his shop without any license. To pursue the information I along with force rushed to Thekuachak Bazar and arrived there at about 20:55 hrs and found that one person is selling alcoholic liquors to the different customers and on search the below noted quantity of alcoholic liquors were found in his shop. On asked he failed to give any satisfactory answer for selling and possessing the below noted quantity of alcoholic liquors. On ask he disclosed his name as noted above. On enquiry, it was known that he was conducting of business of selling of liquor without any license since last few days. On demand, he failed to produce any license for selling and possessing the liquors. So I arrested the accused person at 21.05 hrs. and seized the below noted quantity of alcoholic liquors from the possession of Sankar Dolai (47) S/O Lt. Sudhir Ch. Dolai of Thekuachak, PS- Nandakumar,, Dist.- Purba Medinipur at 21.15 hrs to 21.45 hrs. under proper seizure list duly signed by the witnesses.

Description of the seized item : 1. 10 (Ten) bottles Country Spirit , each 600 ml.

2. 05 (five) ltrs. I.D. liquor with one plastic Jaricane.

I also took 01 (one) bottle Country Spirit 600 ml. and 01 (one) ltr. I.D. Liquor seized as sample from the above mentioned category.

Since offence has been committed U/S 46A(c) of Bengal Excise Act-1909. So I pray that a specific case may kindly be started against the arrested accused person namely Sankar Dolai (47) S/O Lt. Sudhir Ch. Dolai of Thekuachak, PS- Nandakumar, Dist.- Purba Medinipur, U/S 46A(c) of Bengal Excise Act-1909.
